# **TERMS OF REFERENCE**

#### The Extraordinary Chambers in the Courts of Cambodia (ECCC)

#### **Background**

The Extraordinary Chambers in the Courts of Cambodia (ECCC) is responsible for prosecuting senior leaders of the Democratic Kampuchea and those who were most responsible for the crimes committed during the Khmer Rouge regime from 17 April 1975 to 6 January 1979.

The Victims Support Section (VSS) of ECCC is entrusted with facilitating victims participation in ECCC proceedings. On October 27, 2015, VSS and United Nations Trust Fund to End Violence against Women (UN Trust Fund) mutually signed an agreement to implement the second phase of the project: "Promoting Gender Equality and Improving Access to Justice for Female and GBV Survivors under the Khmer Rouge Regime - Phase II", commencing on 1 January 2016 and ending on 31 December 2018.

#### **Overall Purpose of the Consultancy**

To ensure the implementation of UNTF project - phase 2 is effectively and efficiently carried-out for the benefits of GBV Civil Parties and other female GBV survivors.
