Pre-Trial Chamber's Notice to the Parties by Email:

1. Pursuant to Internal Rules 77(3) and 77(5), the Pre-Trial Chamber will conduct a hearing in Case No. 003/07-09-2009-ECCC/OCIJ (PTC35) in relation to the International Co-Prosecutor's Appeal of the Order Dismissing the Case against MEAS Muth (D266/2), the National Co-Prosecutor's Appeal against the International Co-Investigating Judge's Closing Order in Case 003 (D267/3) and MEAS Muth's Appeal against the International Co-Investigating Judge's Indictment (D267/4).
 2. The Pre-Trial Chamber is of the view that, this hearing, based exclusively on the written submissions filed, could take place between **25 and 29 November 2019**.
 3. The Pre-Trial Chamber hereby invites the Office of the Co-Prosecutors and the Defence counsels to file submissions by close of business on **Wednesday 11 September 2019**:
 - confirming their availability between **25 and 29 November 2019**; and
 - informing the Pre-Trial Chamber as to the time needed to address the Court.
 4. A scheduling order will be issued upon the reception of the above-mentioned submissions.

Notification de la Chambre préliminaire aux Parties par courrier électronique :

1. En application des règles 77 3) et 77 5) du Règlement intérieur, la Chambre préliminaire tiendra une audience dans le cadre du dossier n° 003/07-09-2009-ECCC/OCIJ (PTC35) concernant l'Appel du co-procureur international contre l'Ordonnance de non-lieu en faveur de MEAS Muth (D266/2), l'Appel de la co-procureure nationale contre l'Ordonnance de clôture du co-juge d'instruction international dans le dossier n° 003 (D267/3) et l'Appel de MEAS Muth contre la décision de renvoi en jugement rendue par le co-juge d'instruction international (D267/4).
2. La Chambre préliminaire considère que cette audience, fondée exclusivement sur les arguments écrits déposés par les Parties, pourrait avoir lieu entre le **25 et le 29 novembre 2019**.
3. Par la présente, la Chambre préliminaire invite donc le Bureau des co-procureurs et les avocats de la défense à déposer leurs observations avant la fin de journée du **mercredi 11 septembre 2019** :
 - confirmant leur disponibilité entre le **25 et le 29 novembre 2019** ; et
 - informant la Chambre préliminaire du temps qu'ils nécessiteront afin de s'adresser à la Cour.

Une ordonnance portant calendrier sera publiée à la réception des observations susmentionnées.
