Written Record of Initial Appearance

Procès-Verbal d'Interrogatoire de Première Comparution

On 9 December 2015, at 12.57 p.m., the Initial Appearance of Mr YIM Tith took place at the premises of the Extraordinary Chambers in the Courts of Cambodia ("ECCC") in Phnom Penh, in the presence of the following:

YIM Tith advised his personal information as follows:

YIM Tith declared that he is able to read, write, and understand Khmer, but that he is not able to read, write, or understand English or French. Therefore, the original of this Written Record of Initial Appearance was transcribed in Khmer by Greffier Chhay Chanlyda.

The ICIJ advised YIM Tith that:

- he had the right to remain silent and that no adverse inference may be drawn from his exercise of that right,
- he was free to make a statement before or after the notification of the charges,
- he had the right to legal representation, and
- he could consult with his co-lawyers before making any such statement.

Neither the suspect nor his co-lawyers elected to make a statement or to submit observations at this time.

The ICIJ advised the suspect of the alleged criminal acts of which the ICIJ has been seized by the Office of the Co-Prosecutors ("OCP") through the Third Introductory Submission dated 20 November 2008 ("3IS"), the Supplementary Submission regarding Sector 1 Crime Sites and Persecution of Khmer Krom dated 18 July 2011 ("1SS"), the Supplementary Submission regarding Forced Marriage and Sexual or Gender-Based Violence dated 24 April 2014 ("2SS"), the Response to a Forwarding Order and

Supplementary Submission regarding Wat Ta Meak dated 4 August 2015 ("3SS"), and the Response to Forwarding Order dated 5 November 2015 and Supplementary Submission regarding the Scope of Investigation into Forced Marriage in Sectors 1 and 4 dated 20 November 2015 ("4SS") (collectively "the Submissions"), and for which he is alleged to be responsible either as a senior leader of Democratic Kampuchea or as one of those most responsible for these alleged crimes.

The ICIJ provided Khmer and English copies of the submissions listed directly above to YIM Tith and his Co-Lawyers.

The ICIJ noted that advance access to the Case File was granted by order of 4 December 2015.

The ICIJ informed YIM Tith that the alleged criminal acts set out in the Submissions have been given the following legal characterisation by the OCP:

- Violation of Articles 209, 210, 500, 501, 503, 504, 505, 506, 507, and 508 of the 1956 Penal Code (Homicide, Torture, and Religious Persecution);
- Violation of the Convention on the Prevention and Punishment of the Crime of Genocide of 1948 (Genocide of the Khmer Krom and Vietnamese):
- Crimes Against Humanity (Murder, Extermination, Enslavement, Imprisonment, Torture, Rape, Persecution on political, racial and religious grounds, and Other Inhumane Acts); and
- Grave Breaches of the Geneva Conventions of 1949 (Wilful Killing, Wilfully Causing Great Suffering or Serious Injury to Body or Health, Unlawful Deprivation or Transfer, and Unlawful Confinement of a Civilian).

The ICIJ advised YIM Tith that:

- these offences are defined and punishable under Articles 3 (new), 4, 5, 6, 29 and 39 of the ECCC Law,
- the alleged criminal acts are under judicial investigation, and
- that the Co-Investigating Judges are not bound by the legal characterisation as chosen by the OCP.

YIM Tith was advised that, at this time, there is clear and consistent evidence indicating that he may be criminally responsible for the commission of crimes from 17 April 1975 to 6 January 1979 at the following sites referred to in the submissions:

The ICIJ advised YIM Tith that he is charged with the following crimes in his capacity as the member and later Secretary of Kirivong District and Sector 13 committee member in the Southwest Zone; and as Secretary of Sector 1, Secretary of Sector 3, Secretary of Sector 4 and Deputy Secretary of the Northwest Zone of Democratic Kampuchea.

The ICIJ advised YIM Tith that he is charged with the following crimes:

Genocide

The ICIJ advised YIM Tith that he may be responsible for the crime of Genocide, perpetrated against the Khmer Krom, at the following sites through the modes of liability listed below:

Sector 13, Southwest Zone

Crime Site 1: Wat Pratheat security centre

Genocide by killing members of the group

Modes of Liability: planning, ordering, instigating, superior responsibility, commission (via joint criminal enterprise first category "JCE 1"), and commission (via joint criminal enterprise second category "JCE 2").

Crime Site 2: Kraing Ta Chan security centre

Genocide by killing members of the group

Modes of Liability: commission (via JCE 1).

Crime Site 3: Preil Village

Genocide by killing members of the group, and deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part. *Modes of Liability:* commission (*via JCE 1*).

Crime Site 4: Wat Angkun

Genocide by killing members of the group and deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part. *Modes of Liability:* commission (*via JCE 1*).

Crime Site 5: Slaeng Village forest execution site

Genocide by killing members of the group and deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part. *Modes of Liability*: commission (*via* JCE 1).

Crime Site 6: Prey Sokhon execution site and Wat Ang Serei Muny

Genocide by killing members of the group. *Modes of Liability:* commission (*via* JCE 1).

Genocide by killing members of the group.

Modes of Liability: commission (via JCE 1).

Sector 2, Northwest Zone

Crime Site 17: Phum Veal security centre

Crimes against Humanity

The ICIJ advised YIM Tith that there is clear and consistent evidence indicating that he may be criminally responsible for Crimes against Humanity committed as part of a widespread or systematic attack directed against a civilian population on national, political, ethnical, racial or religious grounds.

The ICIJ advised YIM Tith that he is charged with the following Crimes against Humanity at the following sites:

Sector 13, Southwest Zone

Crime Site 1: Wat Pratheat security centre

Crimes: murder; extermination; enslavement; imprisonment; torture; persecution on political grounds against "17 April people" and on political and racial grounds against the Khmer Krom through the underlying offences of murder, extermination, enslavement, imprisonment, torture, and other inhumane acts (confinement/working in inhumane conditions); other inhumane acts (confinement/working in inhumane conditions).

Modes of Liability: planning, ordering, instigating, superior responsibility, commission (via JCE 1), and commission (via JCE 2).

Crimes: murder; extermination; imprisonment; torture; persecution on political grounds against "17 April people" and on political and racial grounds against the Khmer Krom through the underlying offences of murder, extermination, imprisonment, torture, and other inhumane acts (forcible transfer and confinement in inhumane conditions); other inhumane acts (forcible transfer and confinement in inhumane conditions).

Modes of Liability: commission (via JCE 1).

Grave Breaches of the Geneva Conventions of 1949

The ICIJ advised YIM Tith that there is clear and consistent evidence that he may be responsible for the following Grave Breaches through the following modes of liability, committed as part of an international armed conflict between the Democratic Kampuchea and the Socialist Republic of Vietnam:

Violation of Articles 501 and 506 of the 1956 Penal Code

The ICIJ advised YIM Tith that there is clear and consistent evidence that he may be criminally responsible for violations of Articles 501 and 506 of the 1956 Penal Code. The ICIJ advised YIM Tith that violations of Articles 501 and 506 (Premeditated Murder) of the 1956 Penal Code are defined and punishable under Articles 3 (new) and 39 of the ECCC Law.

The ICIJ advised YIM Tith that he is charged with the crime of Premeditated Murder, committed at the following sites through the following modes of liability:

A break was taken at 13.38. The Initial Appearance recommenced at 13.58.

Joint Criminal Enterprise

The ICIJ advised YIM Tith that he may be responsible for the crimes against humanity listed above and occurring within Sectors 1, 2, 3, 4, 5 and 7 in the Northwest Zone of Democratic Kampuchea, through, *inter alia*, his participation in a joint criminal enterprise. The ICIJ informed him that there is clear and consistent evidence that as of early or mid-1977 until at least 6 January 1979, Ta Mok engineered, coordinated and carried out, in concert with YIM Tith, IM Chaem, Ta Chay and other trusted Southwest Zone cadres installed at the zone, sector and district level in the Northwest Zone, an operation for the successful implementation of the following policies of the Communist Party of Kampuchea ("CPK") in the Northwest Zone:

- The establishment and operation of cooperatives and worksites, which was implemented through the enslavement of the population;
- The regulation of marriage, which was implemented through, *inter alia*, the forced marriage of the inhabitants of the Northwest Zone;
- The reeducation, through imprisonment, forced labour, and subjection to inhumane conditions of so-called 'bad elements' and the killing of 'enemies' and 'bad elements' both inside and outside the CPK ranks; and

• The targeting of specific groups, namely Northwest Zone CPK cadres and former officials of the Khmer Republic, including both civil servants and former military personnel and their families.

The participants in this joint criminal enterprise intended to and implemented these policies through the commission of crimes under the ECCC jurisdiction namely the crimes against humanity of imprisonment, murder, extermination, enslavement, other inhumane acts, and persecution.

In relation to the Khmer Krom, the ICIJ advised YIM Tith that he may be responsible for crimes committed in the Southwest Zone at Wat Pratheat security centre, Kraing Ta Chan security centre, Preil Village execution site, Wat Angkun execution site, Slaeng Village forest execution site, Prey Sokhon execution site and Wat Ang Serei Muny; and in the Northwest Zone at Kampong Kol sugar factory, Phum Veal security centre, Svay Chrum security centre, Tuol Seh Nhauv execution site, Prey Krabau execution site, Kampong Prieng commune (including Kach Roteh, Thmei and Sala Trav villages), and Reang Kesei commune, through his participation in a joint criminal enterprise. This joint criminal enterprise existed from at least 1976 to January 1979, and included Ta Mok, YIM Tith, KHIEU Tom, Yeay Bau, PECH Chim, SEK Sam At *alias* Yeay Rim and other Southwest Zone cadres, who shared the common objective to implement, in specific areas of Democratic Kampuchea, a nation-wide plan for the elimination, in whole or in part, of the Khmer Krom.

The participants in this joint criminal enterprise intended to and implemented the plan through the commission of crimes under the jurisdiction of the ECCC, namely genocide by killing members of the group, causing serious bodily or mental harm to members of the group, and deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part; the crimes against humanity of murder, extermination, enslavement, deportation, imprisonment, torture, persecution, and other inhumane acts; and grave breaches of the Geneva Conventions.

Lastly, the ICIJ advised YIM Tith that he may be responsible for crimes committed at Wat Pratheat security centre through his participation in a joint criminal enterprise. This joint criminal enterprise existed from at least 17 April 1975 until 6 January 1979, and included YIM Tith, KHIEU Tom, Yeay Bau, Ta Pring and security centre personnel, who shared the common objective of furthering a system of ill-treatment.

The participants in this joint criminal enterprise intended to and implemented the plan through the commission of crimes under the jurisdiction of the ECCC, namely the crimes against humanity of imprisonment, enslavement, torture, murder, extermination, other inhumane acts, persecution, and genocide by killing and causing serious bodily or mental harm to the group.

Indication of crime sites not to be investigated further

The ICIJ announced that he was currently considering not investigating the following allegations further and will invite the parties in due course to make representations on the matter:



- allegations relating to Damnak Reang execution site (1SS, para. 9)
- all allegations relating to Trach Kraol Prison also known as Boeng Bat Kandal prison (1SS, para. 16; 2SS, para. 7)
- all allegations relating to Tuol Purchrey execution site (3IS, para. 73)
- allegations of sexual violence against Khmer Krom and "East Zone Evacuees" within Bakan District, Sector 2, Northwest Zone (2SS, para. 7)
- allegations relating to La-ang Kuoy Yum caves (3IS, para. 70)
- allegations relating to the targeting of Vietnamese within Reang Kesei commune (2SS, para. 8)
- allegations of forced marriage in Krahok village, Banan commune (2SS, para 6; 4SS, para. 6)
- allegations relating to targeting of Vietnamese within Preah Net Preah district (2SS, para. 9)

The ICIJ advised YIM Tith that he may, before the end of the investigation, decide to charge him with additional crimes based on allegations in the submissions should the ICIJ become satisfied that there is clear and consistent evidence indicating that YIM Tith may be responsible for such crimes. He would then be summoned to a further appearance and given sufficient time to prepare his defence.

The ICIJ informed YIM Tith that:

- at all times during the judicial investigation, he has the right to request that the Co-Investigating Judges issue any order or undertake any investigative action that he considers useful for the conduct of the investigation as provided in Internal Rules 55(10) and 58(6);
- that he will be given a reasonable period of time to review the case file and to participate in the investigation;
- that his lawyers have the right to consult the original case file, subject to reasonable limitations to ensure the continuity of the proceedings, as provided in Internal Rule 55(11).

The ICIJ advised YIM Tith that he will not be placed in provisional detention at this time but must remain at the disposal of the ECCC.



YIM Tith will voluntarily surrendere his passport to his local police station in Battambang, and indicated that he may need the passport for occasional travel to Thailand for medical check-up, and he agreed to be present at home for weekly visits by the local police at dates and times to be arranged.

The ICIJ declared he would make an order to that effect to the Judicial Police of the ECCC in due course.

The ICIJ advised YIM Tith that he must notify the ICIJ of any change of address.

The ICIJ advised YIM Tith that under Rule 57(3)(b) of the Internal Rules, all service or notification at the last address provided will be deemed to be valid.

YIM Tith agreed to have documents served on him by email to one or more of his Co-Lawyers.

YIM Tith waived the reading back aloud of this Written Record of Initial Appearance in Khmer.

The audio/video recording ceased at 14.22.

The original of the audio/video recording of this Initial Appearance was labeled and sealed in the presence of YIM Tith and his Co-Lawyers. YIM Tith, his Co-Lawyers, the Greffier, and the ICIJ signed the sealed original of this recording. A copy of this recording was given to YIM Tith.

A copy of this Written Record of Initial Appearance was provided to YIM Tith.

YIM Tith had no objections and agreed to place his thumbprint on it.

The Initial Appearance concluded at 14.55 on 9 December 2015.
