- 3 THE GREFFIER:
- 4 ... behaviour in the courtroom. Two, all cameras, camcorders,
- 5 tape recorders and loudspeakers are prohibited in the courtroom
- 6 except as approved by the President of the Pre-Trial Chamber.
- 7 Three, smoking or bringing food and drinks into the courtroom are
- 8 prohibited.
- 9 Four, all weapons are prohibited into the courtroom except for
- 10 those carried by the ECCC authorized security guards.
- 11 Five, the use of cell phone is prohibited. This prohibition also
- 12 includes phone cameras and audio recordings.
- 13 Six, changing seats or walking around the courtroom is
- 14 prohibited.
- 15 Seven, clapping, cheering, shouting or making loud noises that
- 16 may disrupt the hearing is prohibited.
- 17 Eight, permission must be granted by a security guard before
- 18 entering or exiting the courtroom.
- 19 Nine, pursuant to the Internal Rules of the Extraordinary
- 20 Chambers in the Courts of Cambodia and the applicable laws of the
- 21 Kingdom of Cambodia, the President of the Pre-Trial Chamber may
- 22 take preventive measures or other actions against any person who
- 23 breaches these internal regulations.
