I. PROCEDURAL HISTORY & DISCUSSION

- 1. Disagreements between the Co-Investigating Judges ("CIJs") in this case were registered on 22 February 2013, 5 April 2013, 22 January 2015, and 21 October 2015.
- 2. On 5 August 2016, I provided the Yim Tith Defence with a list of names of Case 004 witnesses testifying in Case 002/02 with corresponding pseudonyms.¹
- 3. On 18 November 2016, I provided an updated version of this list to the Ao An Defence.²
- 4. On 14 December 2016, in Case 003 I issued a Decision on a request by the Meas Muth Defence for an updated list of names and pseudonyms of Case 003 witnesses testifying in Case 002 ("Case 003 Updated Pseudonym Decision"). In the Case 003 Updated Pseudonym Decision, I informed the Meas Muth Defence that in the future the parties are not required to request updated lists of names and pseudonyms. Instead, when the Trial Chamber informs me of any additional names and pseudonyms of Case 003 or Case 004 witnesses testifying in Case 002, I will place them on the respective Case File and notify the relevant parties.
- 5. As this information is also relevant to the parties in Case 004, a copy of the Case 003 Updated Pseudonym Decision is annexed to this Decision.⁴
