I. PROCEDURAL HISTORY

- 1. On 20 November 2008, International Co-Prosecutor ("ICP") filed the Third Introductory Submission alleging that Yim Tith is responsible for crimes within the jurisdiction of the ECCC. Subsequently, the ICP filed further Supplementary Submissions alleging that Yim Tith bears criminal responsibility for further crimes.²
- 2. Disagreements between the Co-Investigating Judges ("CIJs") in this case were registered on 22 February 2013, 5 April 2013, 21 October 2015, and 16 January 2017.
- 3. On 9 December 2015, the International CIJ charged Yim Tith with violations of Articles 501 and 506 of the 1956 Penal Code (homicide), genocide, crimes against humanity, and grave breaches of the Geneva Conventions of 1949.³ On 29 March 2017, the International CIJ issued an order amending the charges to include additional modes of liability.⁴

II. DISCUSSION

- 4. We consider that the judicial investigation against Yim Tith has been concluded.
- 5. Internal Rule 66 (1) mandates that, when the CIJs consider that an investigation has been concluded, they shall notify the parties and their lawyers. The parties shall then have 15 days to request further investigative action, although they may waive such period.
- 6. Internal Rule 23 *bis* (2) provides Civil Party applicants with 15 days from the notification to submit their applications.

FOR THE FOREGOING REASONS, WE:5

7. **NOTIFY** the parties and their lawyers that we consider that the investigation against Yim Tith has been concluded; and
