THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia ("ECCC") is seised of the Parties' submissions regarding an oral hearing on the Closing Order appeals in Case 004.¹

I. PROCEDURAL BACKGROUD AND SUBMISSIONS

- 1. On 1 March 2021, the Pre-Trial Chamber invited the Parties to Case 004, via email, to file submissions on whether the Pre-Trial Chamber should conduct an oral hearing on the appeals against the Closing Orders in Case 004. The Parties were instructed to file their submissions within 3 days of the notification of the email.²
- 2. On 3 March 2021, the International Co-Prosecutor filed her Submissions,³ requesting and oral hearing on the Case 004 appeals,⁴ or in the alternative, that the Parties be allowed to file written submissions on the significance of the Supreme Court Chamber's Decision in Case 004/2 for the disposition of Case 004.⁵
- 3. On 3 March 2021, the Co-Lawyers for the Civil Parties ("Civil Party Lawyers"), via email, requested a filing extension of one (1) day necessitated by certain deactivated ECCC accounts and time differences between the various Co-Lawyers.⁶ On the same day, the Pre-Trial Chamber, via email, granted the Civil Party Lawyers' request and extended the filing deadline by one (1) day.⁷

- 4. On 4 March 2021, the National Co-Prosecutor, via email, submitted that pursuant to the Internal Rules, the Pre-Trial Chamber may decide the appeals on the basis of the Parties' written submissions or decide to hold an oral hearing. The National Co-Prosecutor defers this decision to the Pre-Trial Chamber.⁸
- 5. On 4 March 2021, the Co-Lawyers for YIM Tith ("Co-Lawyers") filed their Submissions, requesting the Pre-Trial Chamber to schedule an oral hearing in Case 004.⁹
- 6. On 5 March 2021, the Civil Party Lawyers filed their Views,¹⁰ requesting the Pre-Trial Chamber to (i) schedule an oral hearing on the appeals against the Case 004 Closing Orders; (ii) provide adequate advance notice of the hearing dates; (iii) provide lawyers with alternative means of participation through videolink, and; (iv) order that all reasonable precautions be taken to mitigate the risk of Covid-19 transmission through participation in the hearing.¹¹ A number of Civil Party Lawyers reserved their right not to participate in an oral hearing, in light of the Covid-19 situation in Cambodia.¹²

II. MERITS

7. The Pre-Trial Chamber recalls its broad discretion, pursuant to Internal Rule 77(3)(b), to decide an appeal or application on the basis of the written submissions of the parties only. Having duly considered the Parties' views,¹³ the Pre-Trial Chamber decides to proceed and determine the appeals against the Closing Orders in Case 004 on the basis of the written submissions only.

8. The Chamber further notes that it remains seised of the International Co-Prosecutor's Request to File Additional Submissions on Her Appeal of the Order Dismissing the Case against YIM Tith.¹⁴

III. DISPOSITION

THEREFORE, THE PRE-TRIAL CHAMBER UNANIMOUSLY HEREBY:

DECIDES to proceed and determine the appeals against the Closing Orders in Case 004 on the basis of the written submissions only.

In accordance with Internal Rule 77(13), this decision is not subject to appeal.

In accordance with Internal Rule 77(3)(c), this decision shall be notified to the Co-Investigating Judges and the Parties by the Greffier of the Pre-Trial Chamber.
