Thanks for your mail. After giving Mr. Koppe some time to consider the BAKC decision, I contacted him on Monday, 27 August to find out how he intends to proceed. He indicated that he is attempting to reactivate his membership in the Amsterdam Bar. Since it appears the main reason why the BAKC decided to exclude him from its list is the fact that he is no longer a member of a foreign bar association, he is hoping to use his reactivated Amsterdam Bar membership as a basis for applying for readmission to the BAKC. Mr. Koppe also informed me that he intends to challenge the BAKC decision at the Cambodian Court of Appeal before the expiration of the two-month deadline.

For the above reasons, and in order to ensure that Mr. Nuon Chea continues to have adequate legal representation during this critical period leading up to the Case 002/02 trial judgement delivery and any possible appeal, I intend to maintain Mr. Koppe as the International Co-Lawyer for Mr. Nuon Chea at least until the matter is settled by the Cambodian Court of Appeal.
