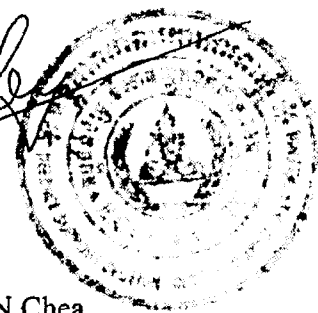
**Re: Termination of Your Legal Services Contract to Represent Mr. NUON Chea at the ECCC**

Dear Mr. Victor Koppe:

1. I am writing in connection with the attached letter dated 11 December 2018 from the Bar Association of the Kingdom of Cambodia ("BAKC") reminding me of its decision of 16 August 2018 to exclude you from the list of foreign lawyers authorized to practice in the courts of Cambodia. I have just received the English translation of the letter, which is also attached.
2. In light of the very clear wording by the BAKC, which is the only body with the power to authorize the practice of law in Cambodia, I regret to inform you that the Defence Support Section ("DSS") cannot continue to maintain you as the International Co-Lawyer for Mr. NUON Chea. Accordingly, I hereby notify you that your authorization to represent Mr. NUON Chea before the ECCC has been terminated **with effect from 11 December 2018**. However, in keeping with established DSS practice, you will be granted until 31 December 2018 to complete certain administrative formalities such as the check-out procedure and to hand over any case-related material to Mr. NUON Chea's National Co-Lawyer. Any administrative authorization previously granted to you for the period after 31 December 2018 is hereby rescinded.
3. I take this opportunity to thank you for your many years of service with DSS and I wish you good luck in your future endeavors.
