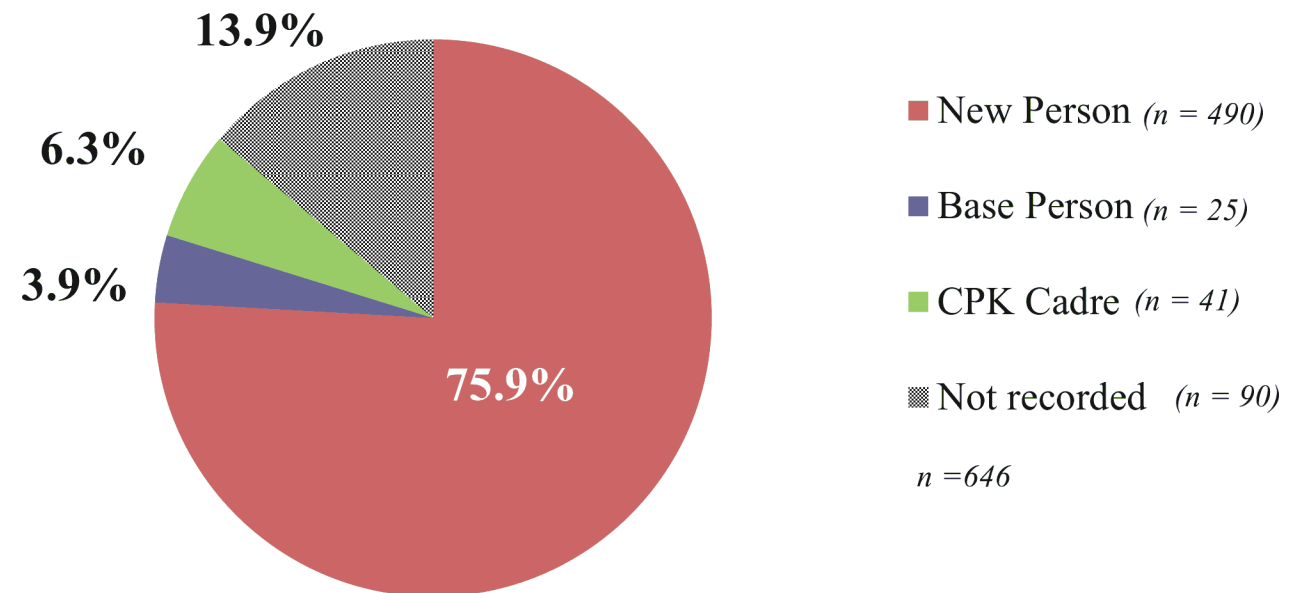

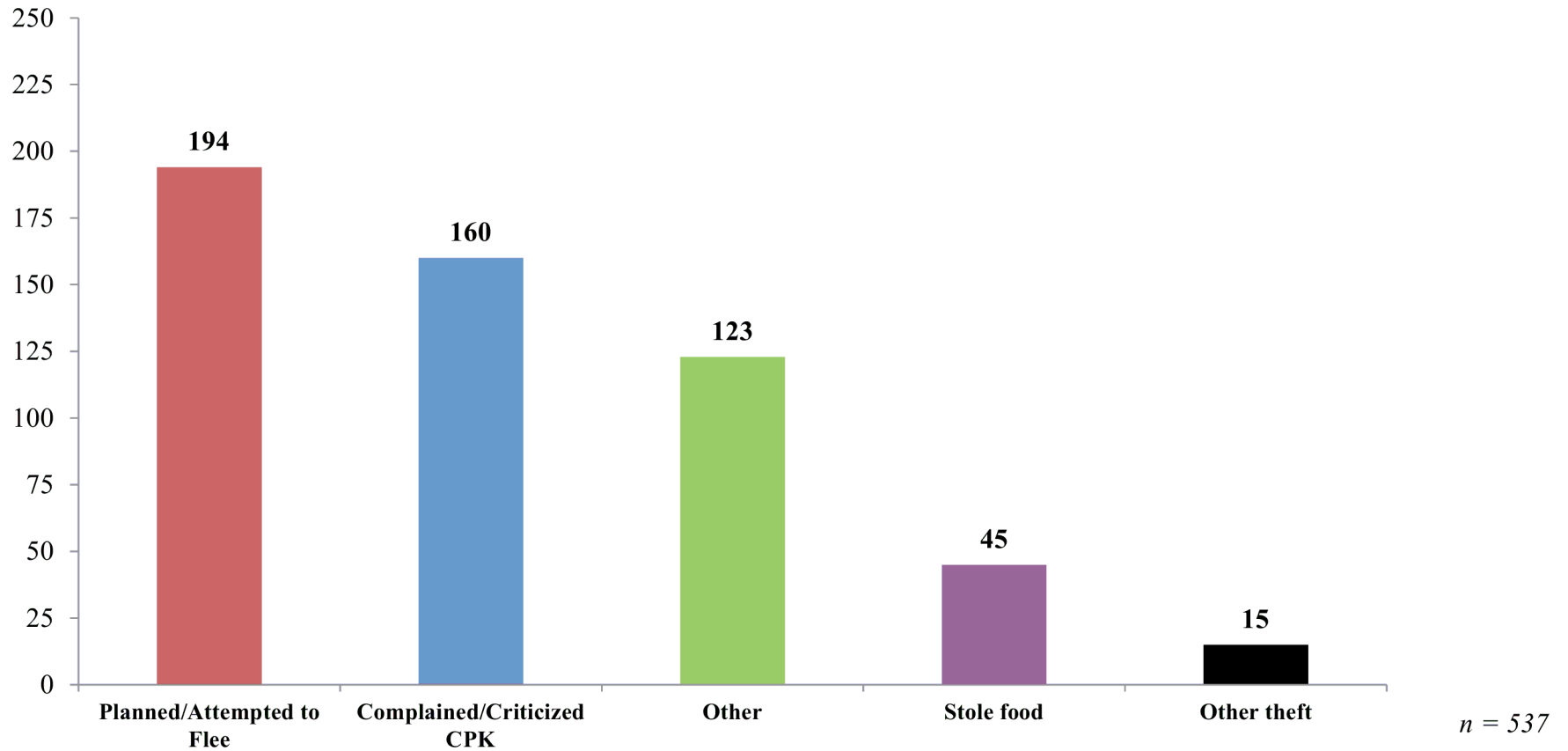

Figure 1.1 New People vs Base People at KTC

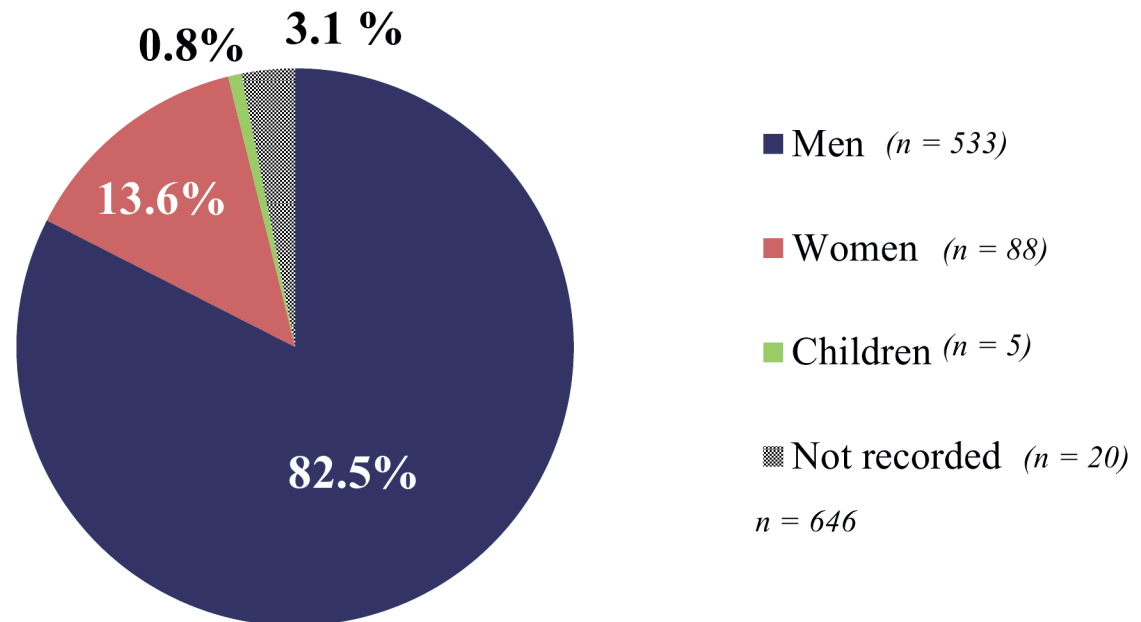

Figure 1.2 Alleged Offences of KTC Prisoners

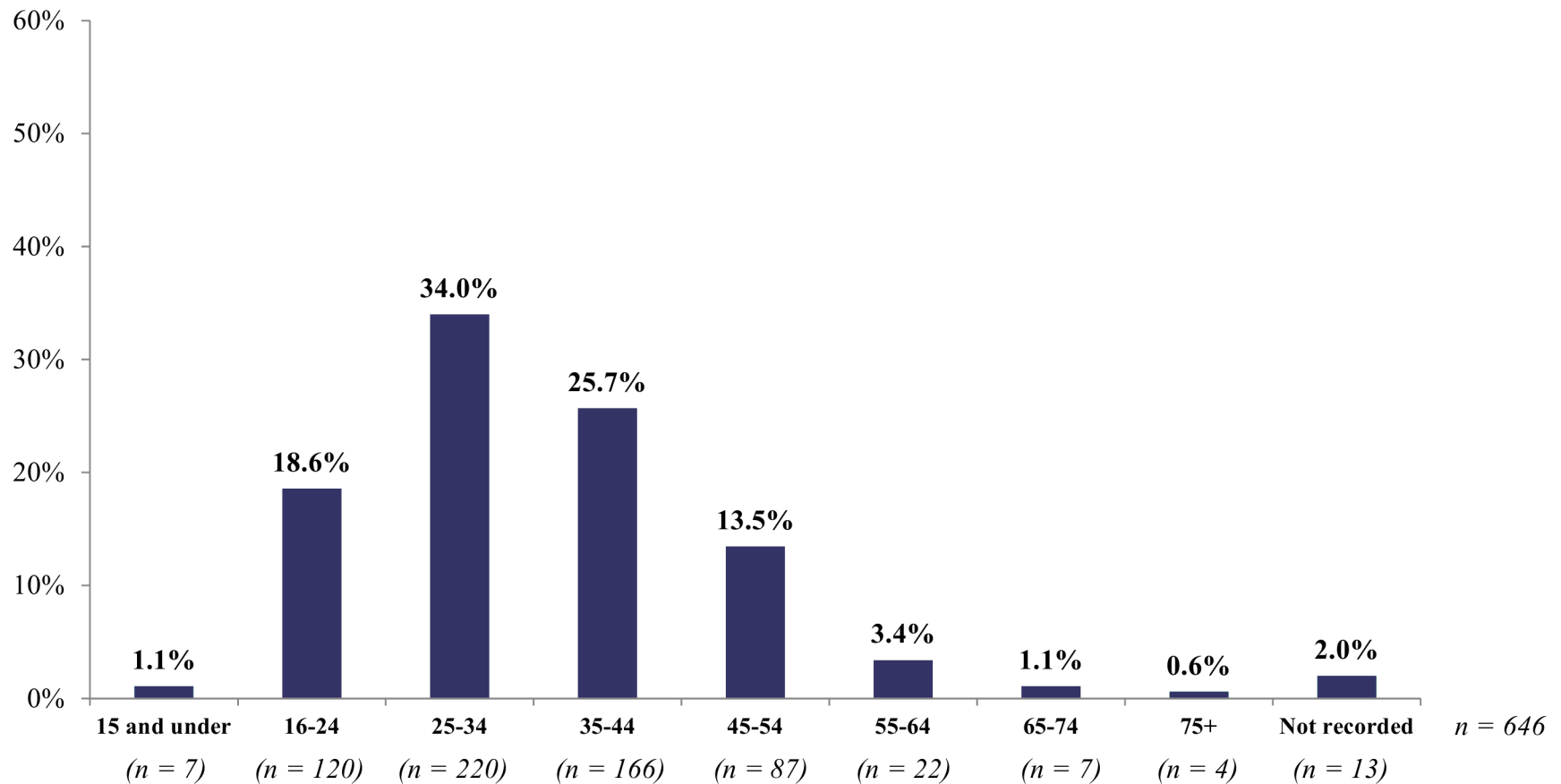

Figure 1.3 Male and Female Prisoners at KTC

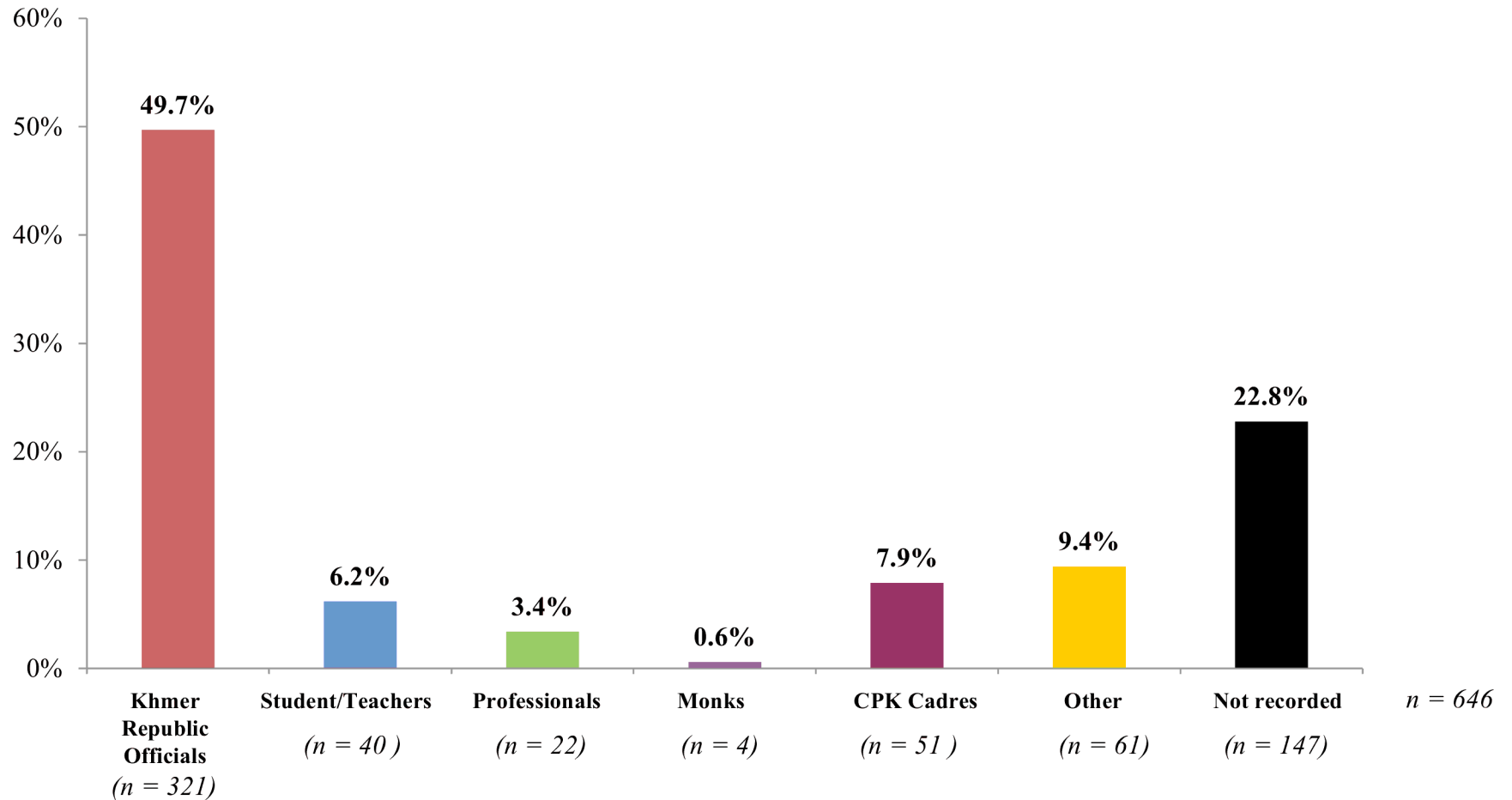

Figure 1.4 Ages of Prisoners at KTC

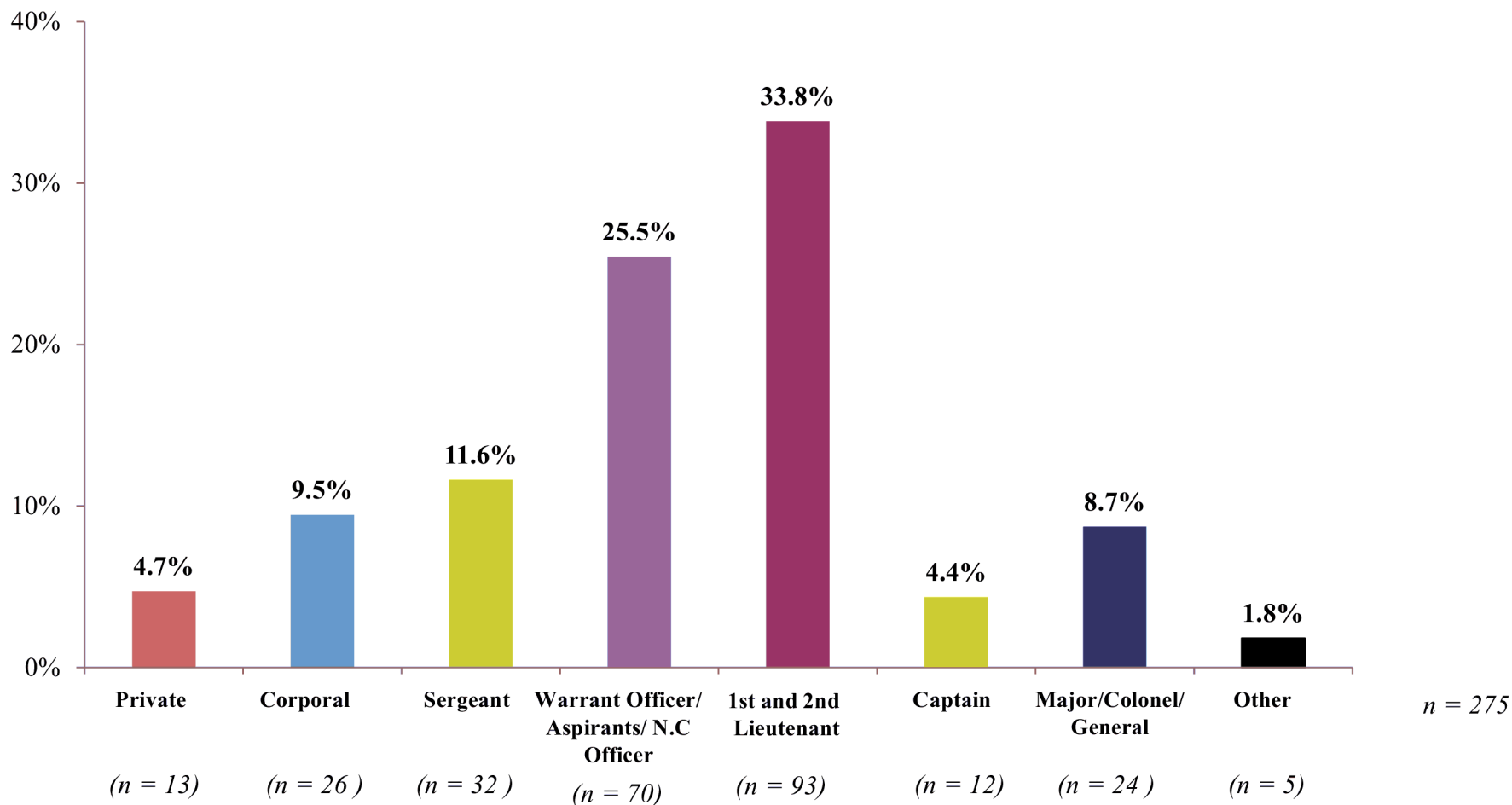

Figure 1.5 Former Occupations of KTC Prisoners

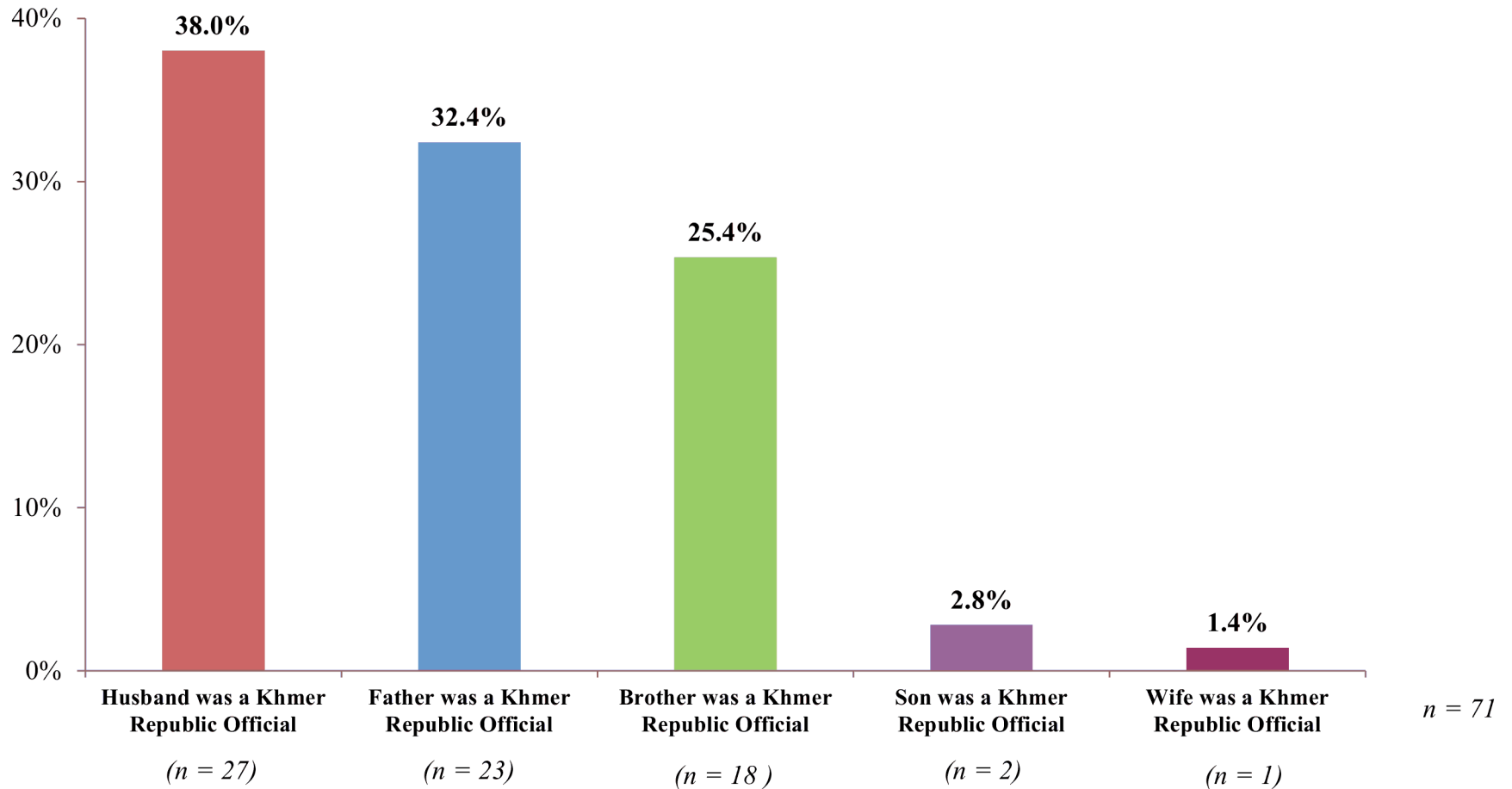

Figure 1.6 Ranks of former Lon Nol soldiers imprisoned at KTC

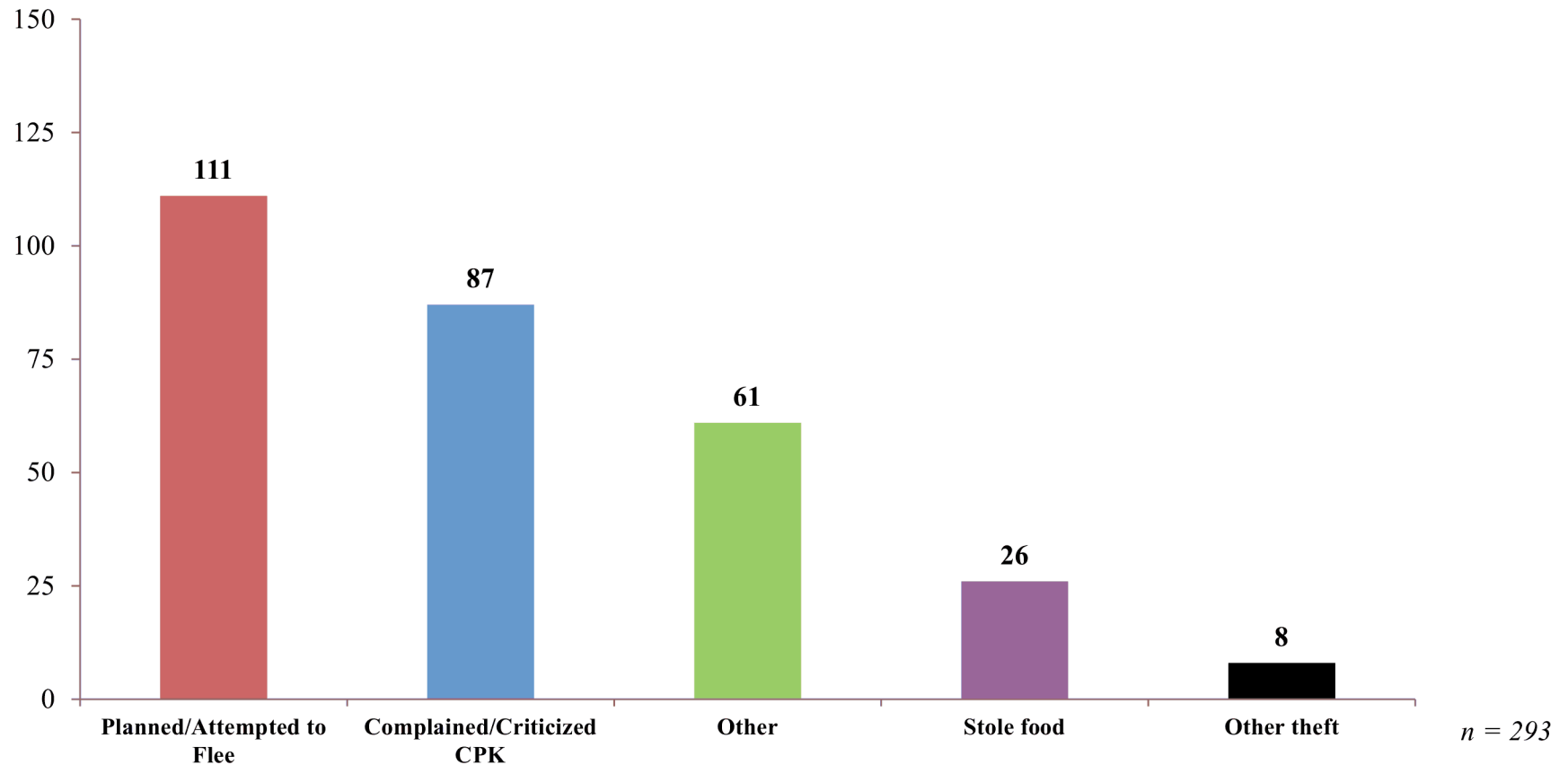
