**I, Judge NIL Nonn**, President of the Trial Chamber of the Extraordinary Chambers in the Courts of Cambodia;

**NOTING** the resignation of Judge Jean-Marc LAVERGNE, effective 29 March 2019;

**RECALLING** article 11 new of the Law on the establishment of the Extraordinary Chambers in the Courts of Cambodia for the prosecution of crimes committed during the period of Democratic Kampuchea and Internal Rule 79(4), which permit the President of the Trial Chamber to designate a Reserve Judge to sit in the absence of a sitting Judge following consultation with the remaining judges;

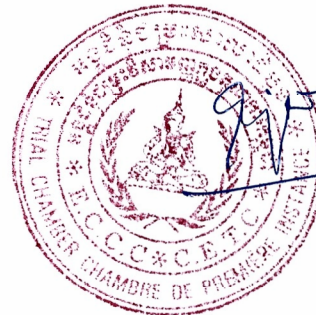
**COGNISANT** that further matters may arise before the Trial Chamber in Case 002/02 which will require consideration by a fully-constituted bench;

**FOLLOWING** consultation with the three remaining judges;

**HEREBY**

**DESIGNATE Judge Martin Greg KAROPKIN** as a sitting judge in the absence of Judge Jean-Marc LAVERGNE, who resigned as a full-time sitting judge of the Trial Chamber of the ECCC, until such time as a full-time sitting judge of the Trial Chamber of the ECCC is appointed.
