RE: Imminent termination

Dear Co-Lawyers,

The Supreme Court Chamber is in receipt of your motion to "issue an urgent order to the ECCC Administration to reinstate all members of the NUON Chea Defence Team immediately until the Supreme Court Chamber determines otherwise" (F46/3), and email dated 30 August 2019.

The Chamber recalls that it terminated further proceedings against NUON Chea on 13 August 2019 following his death on 4 August 2019 (F46/3). The Defense Support Section Chief informed the Chamber on 15 August 2019 that "Court funded legal aid for representation before the Extraordinary Chambers is provided for eligible indigent persons only. Eligibility for financial aid ceases with the demise of such persons. Please be informed that on 9 August 2019, DSS notified NUON Chea's Co-Lawyers and legal consultants of the decision to terminate Court funded legal aid. The contracts of the Co-Lawyers will lapse on 31 August 2019. The contracts of legal consultants will be terminated effective 23 August 2019."

The Chamber considers that the administration of the legal aid scheme before the Extraordinary Chamber falls within the autonomous ambit of the Defense Support Section under Article 11 of the Internal Rules. In the circumstances of the present case, the Chamber has no jurisdiction to intervene in the dispensation of public moneys following the death of a person otherwise eligible for legal aid under the Internal Rules and Legal Assistance Scheme.

Nevertheless, the Chamber remains seized of the Urgent Request concerning the Impact on Appeal Proceedings of NUON Chea's Death Prior to the Appeal Judgement (F46/2). In these circumstances, the Chamber considers it appropriate to maintain the Co-Lawyers' access to the ECCC email system, Zylab and notification until further notice, and so directs.

This constitutes the Supreme Court Chamber's response to F46/4.

Subject: Imminent termination and pending requests

Importance: High

Dear Supreme Court Chamber, dear parties,

The Co-Lawyers for Nuon Chea (the "Defence") write to advise that as of tomorrow, 31 August 2019, the termination of our contracts by the Office of Administration takes effect. Similarly, our team's termination was to take effect as of last Friday, 23 August 2019.

Despite its pending requests (e.g., F46/2, F46/4) before this Chamber, the Defence anticipates that all members of its team will shortly be removed from all relevant systems, including e-mail, the case file notification, and Zylab.

As indicated in its email to this Chamber on 19 August 2019, the Defence requests that the Chamber urgently direct the Office of Administration to retain the Nuon Chea Defence Team at least on a budget that guarantees the minimum functions of the team while the Chamber decides on its pending request F46/2. This allows the Defence to engage with the Chamber regarding the pending request (F46/2).

On 29 August 2019, the Co-Prosecutors filed their response (F46/2/4) to the Defence's request (F46/2) in English, with Khmer translation to follow. The Defence intends to request for leave to reply to the Co-Prosecutors' response once the Khmer translation is notified. However, the Defence will obviously not be able to do so if indeed it is terminated as of 31 August 2019.

The Defence, therefore, once again requests that the Chamber issue an urgent order to retain the Nuon Chea Defence Team while it decides on the Defence's pending request F46/2.
