SUBJECT: List of all the declassified documents are a result of declassification in Case 002

1. On 20 March 2023, the Chamber filed its *Decision on Guidelines for Reclassification of Documents on Case File 002 (F71/1/1/8)*.
2. On 23 April 2023, the Chamber filed its *Order to the Records and Archives Unit for Reclassification of Documents on Case File 002 (F71/1/1/9)*, wherein it directed RAU to declassify case file documents in accordance with the underlying annex and in conformity with **F71/1/1/8**. In addition, the Chamber required RAU to “publish a list of all the documents that have been made public as a result of declassification”.
3. On 19 January 2024, the Chamber filed its *Decision on the Release and Notification of Documents Declassified as “Public” without Redaction in Case File 002 (F88)* requiring RAU to declassify 8,716 records. RAU completed digital reclassification of the underlying records in ZyLAB on 31 January 2024.
4. On 26 April 2024 and 14 June 2024, the Chamber respectively issued its First (**F89**) and Second (**F90**) *Decisions on the Release and Notification of Documents Reclassified as “Public” with Redaction in Case File 002*, requiring RAU to declassify 14,700 records. RAU completed digital reclassification of the underlying records in ZyLAB on 25 July 2024.
5. As of date, RAU has completed reclassification of all related records as documented in the following:
 - a. **Annex A:** Documents declassified to public without redaction (8,659 records totaling 52,090 pages)

- b. **Annex B:** Documents declassified to public with redaction (15,051 records totaling 159,119 pages)
6. This memorandum constitutes RAU's implementation of the Chamber's orders on reclassification in Case 002 and notification to the parties and public.
