# ORDER TO THE RECORDS AND ARCHIVES UNIT FOR RECLASSIFICATION OF DOCUMENTS ON CASE FILE 002

#### I. INTRODUCTION

1. Reference is made to the Supreme Court Chamber's "Decision on Guidelines for Reclassification of Documents on Case File 002," ("Decision on Reclassification") dated 20 March 2023, which adopts general guidelines for the reclassification of documents in the Case File in Case 002/12-09/2007/ECCC/SC ("Case File 002").

2. Pursuant to Article 12 of the Practice Direction on Classification and Management of Caserelated Information (Rev.1) ("Practice Direction on Classification"), the Supreme Court Chamber, as the last judicial office seised of Case File 002, has completed its review of all documents included in the case file for the purposes of reclassification in accordance with the Decision on Reclassification.

#### **II. DIRECTIVE TO RECORDS AND ARCHIVES UNIT**

3. Accordingly, the Supreme Court Chamber hereby directs the Records and Archives Unit ("RAU") to declassify the documents in Case File 002 pursuant to the attached spreadsheet ("Annex A"). To facilitate redaction of documents D3, D108/55, D83, and D196, four additional sub-annexes (Annex A(i), A(ii), A(iii), and A(iv)) are attached. The status of Reclassification of each document is defined therein as follows:

- a. "DECLASSIFY" indicates that the document(s) should be declassified as Public;
- b. "NO ACTION" indicates that no action is required; and
- c. "REDACT" indicates that the document(s) should be redacted of sensitive or identifying information (most commonly names, contact details such as telephone numbers or residential addresses) in accordance with the guidelines contained in the Decision on Reclassification.

As a general rule, the Supreme Court Chamber requires that all names of civil parties and protected witnesses including identifying information such as contact details and family information appearing in the title of any document be redacted.

#### **III. DISPOSITION**

#### FOR THE FOREGOING REASONS, THE SUPREME COURT CHAMBER:

**DIRECTS** RAU to declassify the documents in Case File 002 in accordance with the attached spreadsheet ("Annex A") and in comformity to the Decision on Relassiciation. RAU is further

required to publish a list of all the documents that have been made public as a result of declassification, after being filed and notified to all parties.
