Your Excellency,

The International Committee of the Red Cross (ICRC) in Phnom Penh would like to present its compliments to the Extraordinary Chambers of the Court of Cambodia (ECCC). As an impartial, neutral, and independent humanitarian organization operating through its representation in the Kingdom of Cambodia since 1979, the ICRC Mission in the Kingdom of Cambodia continuously develops and implements humanitarian activities in partnership and coordination with various Cambodian authorities in areas such as, inter alia, physical rehabilitation, detention, restoring and maintaining family links, and promotion of International Humanitarian Law.

We have the privilege of extensive cooperation in favour of persons deprived of their freedom with the Directorate General of Prisons (DGP) under the Ministry of Interior of the Kingdom of Cambodia, as part of a Memorandum of Understanding (MoU) signed with the Royal Government of Cambodia in 1998. As per that agreement, the ICRC carries out regular visits to places of detention with a purely humanitarian objective to monitor detainees' material and psychological conditions as well as treatment. Following those visits, we share observations and recommendations in a confidential and constructive manner with the authorities concerned. In this frame, our role is to support and complement the efforts of the relevant Cambodian authorities in the fulfilment of their duties and responsibilities.

In accordance with the ICRC's prior official correspondence PPO/00023 - DFIS addressed to you on February 3, 2023, the ICRC hereby informs you that an ICRC delegate successfully paid a visit to Mr Khieu Samphân on the 16 of March 2023, in his new detention facility, namely Kandal Provincial Prison, under the responsibility of the DGP.
