Subject: Interim Recognition as Civil Party

1. Your Civil Party Application Form has been received by the Greffiers of the Trial Chamber and, upon instruction from the Judges of the Trial Chamber, placed on the Case File as indicated above.
2. You are now recognized, as an interim measure, as a Civil Party in the proceedings until the Initial Hearing in this Case, when your application will be considered in accordance with Internal Rule 83.

Legal Representation

3. In addition, the Greffiers have also received your indication that you want KIM Mengkhy, Martine JACQUIN and Philippe CANONNE to be your legal representative/s in this case and

the relevant power of attorney attached thereto. Accordingly, unless otherwise decided by the Trial Chamber or provided for in the Internal Rules, any participation as Civil Party will be done through your lawyer/s.

Trial Chamber Power to Declare a Civil Party Application Inadmissible

4. The Trial Chamber may make a formal decision with respect to the admissibility of your application, and reject it if it considers that the legal criteria identifying the victim status as set out in the Internal Rules and in the Practice Direction on Victim Participation are not fulfilled.

Respect of Confidentiality

5. You should also be aware that, through your participation as a Civil Party, you, your lawyers and/or other persons who may assist you may have access to confidential information contained in the Case File. Only the ECCC Judges can decide to make such information public. You are bound not to disclose any confidential information.

Notification of Witness Lists and Other Materials

6. Following this letter, your lawyers will be notified of the list of witnesses and experts that the Co-Prosecutors intend to have summoned at trial, as well as of any other materials relevant thereto. Pursuant to the provisions of Internal Rule 80(2), any Civil Party who wishes to summon any witnesses or experts who are not on the list filed by the Co-Prosecutors shall submit an additional list within 15 days from the notification of the Co-Prosecutors list.
