Summary of Proceedings

<u>Submission of documents considered to be of particular relevance in relation to the Case 002/01</u>

The Co-Prosecutors presented its last document relevant to the Case 002/01 concerning KHIEU Samphan, followed by the presentation of documents considered relevant for the historical background regarding IENG Sary and NUON Chea.

IENG Sary's objection concerning the presentation of documents by the Co-Prosecutors

IENG Sary's Defence objected to the Co-Prosecutors statements, arguing that it amounted to an opening statement or a pleading, which was not the purpose of the hearing. The Trial Chamber reminded the parties that the purpose of the hearing was limited to the presentation of documents.

Waiver of IENG Sary's right to be present in the courtroom

The Accused waived his right to be present in the courtroom for the whole day.

Waiver of NUON Chea's right to be present in the courtroom

The Accused waived his right to be present in the courtroom in the afternoon.

Request concerning the translation of document

IENG Sary Defence submitted that an inaccurate translation of the interview between Steve Heder and IENG Sary was provided. The Trial Chamber instructed the Defence counsel for IENG Sary to submit their request to the Co-prosecutors and arrange for a review of the contested translation.

Objection of new Civil Party's names

Counsel for KHIEU Samphan objected to documents presented by the Civil-Party Co-Lawyer which contain Civil Party's names not admitted yet before the Chamber. The Civil-Party Co-Lawyers responded that all the Civil Party have been accepted by the Co-Investigating judges and the Pre-Trial Chamber.

Oral Orders/Decisions:

- Order to bring the Accused IENG Sary (10:27) and NUON Chea (11:57) to the holding cell (waivers of the Accused are attached to this written record).
- Order to bring the three Accused to the detention facility and to return them to the courtroom for the hearing on 14 February 2012.

The hearing will resume on 15 February 2012 at 9:00am.
