

As to the request to appoint specialists who have been examining Mr. IENG Sary to prepare a detailed report and to give testimony, please note the need for the assistance of specialists was addressed in the appointment of Professor Campbell (E238) and Dr. LOR (E239). In particular in E238, the Trial Chamber requests the medical experts to:

- c) Consult with any other qualified person (such as a radiologist) whose assistance might be helpful in interpreting or confirming his conclusions on test results or on the local availability of specific medical tests he considers essential for a diagnosis of IENG Sary's current health status.
- d) Advise the Trial Chamber if any such medical tests are not available in Phnom Penh and/or
