Dear Roger,

This is to confirmed that the two improvements of the holding cells as stated below were done in September 2012.

1. In September 2012 the four monitors in the Holding Cells, including Ieng Sary's cell were repositioned with a wall mounted pivot bracket to better accommodate the detainees.
2. In September 2012 the mattress in detainee Ieng Sary's holding cell was replaced by a new firmer mattress. The accused has confirmed that it was suitable for him, however on 12 Nov 2012, the Holding was further equipped with a recliner hospital bed.
