

Summary of Proceedings

Waiver of the accused to be present in the courtroom

The accused IENG Sary waived his right to be present directly in the courtroom for the whole day due to his health issue (9:06).

The accused NUON Chea waived his right to be present in the courtroom for the afternoon session (11:58).

<u>Presentation of documents relating to the administrative and communication structures</u> <u>during the DK period</u>

The CPLCL concluded their presentation of documents they consider most relevant to the administrative and communication structures of the DK regime. The NUON Chea Defense made a presentation of their proposed documents on the same subject, while the IENG Sary and KHIEU Samphan Defense teams indicated that they did not have any specific document to put before the Chamber.

Ruling on KS Defense request about the use of documents E3/122

The KHIEU Samphan Defense objected to the use of document E3/122 which consists of notes taken by journalists without any audio recording. The Chamber overruled the objection, stating that it will consider the probative value of this evidence in its judgment.

Ruling on NC Defense request for clarification concerning the procedure for to the presentation of documents by the parties

The NUON Chea Defense asked whether the defense may not object to anything that was said during the presentation of documents unless their client submits to questioning or comment on documents. The Chamber reiterated its ruling of the 10 October 2012 on the right of the accused to comment on the documents presented by the other parties. These comments should be made after the other party has completed their presentation.

Ruling on documents to be presented by the NUON Chea Defense

The Chamber informed the NUON Chea Defense that documents E119.1.398 and E3/9 cannot be submitted before the Court at this juncture. The first document, a publication written by Philip Short, can be presented during the testimony of this expert. Concerning the second document, a publication by Stephen Heder, no decision has not been taken yet. However, if Stephen Heder is summoned before the Chamber, then the document can be presented, otherwise the Chamber will provide another opportunity to present the document.

The NUON Chea Defence subsequently indicated that the Co-Prosecutors were permitted on 10 October 2012 to use document E3/89 which is authored by Stephen Heder. OCP stated that it was documents E3/724 and E3/731 which are summaries of the Revolutionary Flags prepared either by Stephen Heder or Professor Ben Kiernan. The Chamber stressed that it did not intend to amend its decision to postpone the presentation of document authored by Stephen Heder until the Chamber decides whether this shall be summoned testify as such postponement is entirely consistent with the good administration of justice.

Warning against the international defence lawyer for NUON Chea, Mr. Ianuzzi

Over the course of the morning hearing, Mr. Ianuzzi proceeded to make several comments with a view to contest or criticize the decisions issued by the Chamber on the conduct of the proceedings. Because of his entirely inappropriate behaviour, the Chamber warned Mr. Ianuzzi that pursuant to Internal Rule 38 on misconduct of a lawyer, continuance of such behaviour may lead to refusal of his participation in the proceedings and a refusal of audience.

Testimony of Civil Party Ms. YIM Sovann (TCCP-169)

The Trial Chamber started questioning the civil party, followed by the Civil Party Lead Co-Lawyers and the Co-Prosecutors. All the Defense teams indicated that they did not have any questions to put to the civil party.


