Summary of Proceedings

Testimony of KAING Guek Eav

The Co-Prosecutors continued to put questions to the Witness.

Observations regarding the presentation of documents

The Defence teams opposed the practice to present to the Witness any documents the authenticity of which had not been confirmed. The Co-Prosecutors and the Civil-Party Lead Co-Lawyers referred to the Trial Chamber's relevant ruling from the day before. The Trial Chamber dismissed the objections and reminded the Co-Prosecutors not to ask the Witness to explain his personal views about documents.

Request for extension of time

The Trial Chamber granted the Co-Prosecutors' request for one half-day of additional time to question the Witness. The NUON Chea Defence did not object to that request.

Waiver of the Accused's right to be present in the courtroom

The Accused IENG Sary and NUON Chea waived their right to be present in the courtroom.
