Summary of Proceedings

Indication of the name of Civil Party Lawyers assigned to question the witness

The Civil Party Lead Co-Lawyer indicates to the chamber that Ms. CHET Vannly and Ms. Elisabeth RABESANDRATANA will take charge of the questioning of the witness as civil party lawyers. The Trial Chamber permits the assignment of the questioning and intervention times to the two civil party lawyers.

<u>Issue concerning the list of documents to be communicated by the parties before questioning of witnesses</u>

The IENG Sary Defence indicates that it did not receive through the Daily Trial Documents interface the list of documents on which OCP intends to rely for questioning. OCP replies that they have used the interface to share the documents on which they intend to rely. The TC instructs OCP to provide the documents to the parties.

Questioning of Witness SALOTH Ban (TCW-586)

The Witness has taken the oath, is assisted by a lawyer, and has been notified of his rights. The Co-Prosecutors question the witness.

Reminder concerning the procedure for objections to a question by duty counsel

After the witness's counsel rose to say that a question could possibly cause his client to incriminate himself, the TC advised that duty counsel should first discuss such matters with his client and that it was the witness's decision whether to respond or not, after consultation with his counsel.
