Summary of Proceedings

IENG Sary's waiver of his right to be present at trial

Counsel for IENG Sary indicates that its client waives his presence for the part of today proceedings related to his medical condition. He also consents to the discussion on his health conditions to be held in public. However, he does not waive his presence for the hearing of the two upcoming witnesses – namely witnesses TCW-487 and TCW-583.

Hearing of ECCC Doctor on IENG Sary's ability to participate in the proceedings

The ECCC doctor maintains that IENG Sary should rest for the remainder of this week without participating to the proceedings neither in person nor remotely from the holding cell. He should be able to participate to the proceedings next week, initially by remote means.

Trial Chamber's decision to adjourn the hearing and to modify the hearings' schedule

Following the ECCC Doctor's report, the Trial Chamber adjourns the hearings and will resume on Monday 28 May 2012 with the hearing of witness TCW-487 or, should Mr. IENG Sary not be able to participate to the proceedings, of witness TCW-488.

Discussion on the documents put before the Chamber for the questioning of witnesses

Judge Lavergne addresses three documents that the parties intend to use during the questioning of witnesses. The documents shall be properly filed as new documents and put before the Chamber in accordance with Rule 87(4). The relevant requests shall be made in writing. The Trial Chamber also stresses that from now on, when documents raise such matters it will inform the parties before the hearing and will not address these issues during the hearing because it is time consuming.

OCP clarifies that the document they intend to use was already included on annex 2 of their April 2011 Documents List and is indexed in E9/31.2. NUON Chea's Defence objects the Trial Chamber's position and requests that, if a request under Rule 87(4) is to be raised, it should be done orally and publicly before the Chamber.
