

Summary of Proceedings

Waiver of the Accused's right to be present in the courtroom

The Accused waived their right to be present in the courtroom (Mr. IENG Sary for the whole day and Mr. NUON Chea for the afternoon session).

Request for clarification of a ruling

The Counsel for IENG Sary requested clarification of a ruling adopted the day before. He asked the Trial Chamber's guidance as to the manner in which the Defence could use the Witness' testimony for the purposes of impeaching the Witness (and avoid their revisiting of the matter as being repetitive). The request was supported by the NUON Chea Defence. In order to facilitate the matter, the Trial Chamber asked the Counsel for IENG Sary to submit a memo to the Senior Legal Officer.

Inquiry about NUON Chea's written request

NUON Chea Defence inquired about an email sent to the Senior Legal Officer on 24 April in respect of a list of publications of the Trial Chamber Judges. The President informed him that the Trial Chamber would rule on the request in due course.

Testimony of Witness OEUN Tan (TCW-488)

After the initial questions put to the Witness by the President of the Trial Chamber, the Co-Prosecutors commenced their questioning. Subsequently, the Civil Party Lead Co-Lawyers put questions to the Witness. Finally, Judge LAVERGNE and the President questioned the Witness.
