Summary of Proceedings

Waiver of the Accused's right to be present in the courtroom

The Accused Mr. IENG Sary and Mr. NUON Chea waived their right to be present in the courtroom (Mr. IENG Sary for the whole day and Mr. NUON Chea for the afternoon session).

Testimony of Witness KHIEV Neou (TCW-321)

The Co-Prosecutor completed their questioning of the Witness. Subsequently, the Civil-Party Lead Co-Lawyers questioned him.

Request alleging discrepancies between audio and written recordings of OCII interview of the witness

The KHIEU Samphan Defence, supported by the NOUN Chea Defence, alleged that there were discrepancies between audio records of the OCIJ interview and the written record of the interview and that it should be given no weight.

Request on the admissibility of documents

The NUON Chea Defence declined to question the witness as it was only permitted by the Chamber to use one of two documents requested for the questioning, namely the

document that appeared on at least one party's documents list, as required by the applicable procedures.

Oral ruling on misconduct of Defence Counsel

The Trial Chamber issued an oral ruling on misconduct of international Defence counsel of the NUON Chea Defence team pursuant to Rule 38 (see below).

Scheduling of next hearing

The Trial Chamber informed the public and the parties that the court would recess and reconvene on 16 July 2012 to hear expert David Chandler

- Oral ruling on misconduct of Defence counsel

During the proceedings in Case 002/01, the Chamber has observed a consistent pattern of misconduct by the NUON Chea Defence, and in particular by the international members of the team. This misconduct has included – but not been limited to – wilful violations of the Chamber's orders and authorized disclosure to the press of confidential or strictly confidential material and statements in court which are

disrespectful of the Court or which otherwise do not accord with the recognized standards and ethics of the legal profession.

In consequence, the Chamber provides notice that these and other examples of misconduct will be brought to the attention of the relevant national bar associations for appropriate actions, pursuant to Internal Rule 38.

The trial Chamber also issues a formal warning, in accordance with Internal Rule 38, and notes that it may invoke the procedures set out in that Rule, independently of any actions taken by individual bar associations.
