#### Oral Orders/Decisions:

- Order to bring the Accused NUON Chea (12:04) to the holding cell (waivers of the Accused IENG Sary (full day) and NUON Chea (afternoon) are attached to this written record).
- Order to bring the Accused back to the detention facility and to return the Accused NUON Chea, KHIEU Samphan and IENG Sary to the courtroom for the hearing on 25 July 2012. Upon receiving his waiver, the Chamber will decide if IENG Sary may follow the hearing from the detention cell.
- The Chamber denied the IENG Sary Defence request to put a new document before the Chamber in order to use it during the questioning to the expert witness. The request was not timely and lacked relevance.
- The Chamber denied the NUON Chea Defence request to make an oral application in order to admit a new document. The application would need to be in writing and in accordance with Internal Rule 87(4), in part because the document is only in English and would at least need to be translated to Khmer.
- Order to bring the Expert Witness David CHANDLER (TCE-11) to his accommodation and to return him to the courtroom for the hearing on 25 July 2012 before 9:00am.
