Summary of Proceedings

Testimony of Witness MEAS Voeun, alias SVAY Voeun (TCW-428)

The Defence teams completed the questioning of the witness.

Ruling on whether parties can pose questions that are not based on any evidence

The Chamber ruled that a question that is not based on material or a Witness Statement that cannot be tested by the Court is not admissible. The court can operate only on evidence. Consequently, if there is a prior Witness Statement that has been heard and examined in this Court, or a document that has been put before the Chamber, these are all viable basis for putting questions to a witness. Instructions from an Accused cannot be given much weight unless the Accused chooses not to exercise his right to remain silent and makes himself available for questioning on that topic.

Reading of Paragraphs of the closing order

Pursuant to Rule 89bis of the Internal Rules, the Greffier read out paragraphs of the Closing Order related to the killing of former LON Nol officers at Tuol Po Chrey (Paragraph 205 to 209, 698 to 711, Paragraph 975 to 977, Paragraph 1105 to 1113 and 1191 to 1193)

Waiver of the Accused's right to be present in the courtroom

The Accused NUON Chea waived his right to be present in the courtroom for the afternoon session (12:11).

Oral decision on Counsel Behaviour

The Chamber ruled upon the continuing improper conduct of Counsel IANUZZI. The ruling found that the conduct fell well below the professional standards expected of any lawyer. The Chamber will forward the complaint to the Bar Association of which the Counsel is a member and will invite the association to consider it together with the earlier complaint made against him.
