### **Summary of Proceedings**

#### **Request by NUON Chea to make remarks**

The Chamber granted NUON Chea's request to make remarks in response to paragraphs in the Closing Order related to Segment 3 of Case 002/01, including military structures, movements of the population and Toul Pou Chrey.

#### **Request by NUON Chea Defence for clarification on ruling**

The NUON Chea Defence requested clarification of a Chamber ruling and that any such clarification be provided in writing for purposes of clarity. The President instructed that such a request needs be in writing as well.

#### **Request of NUON Chea**

The President asked NUON Chea whether he was fit to respond to questions or whether he intended to exercise his right to not respond to questions. NUON Chea said he would not respond to questions.

#### **Remarks by NUON Chea**

NUON Chea made remarks related to paragraphs in the Closing Order related to Segment 3 of Case 002/01, , including military structures, movements of the population and Toul Pou Chrey.
