#### Oral Orders/Decisions:

 Oral Order allowing the Accused IENG Sary and NUON Chea to participate from the holding cells during the day's proceedings based on an assessment of their respective medical reports.

Prior to the proceedings, the Chamber received a medical report from IENG Sary's and Nuon Chea's treating physicians.

It appeared that there was no significant change in IENG Sary's condition since the last expert's assessment and that he cannot attend proceedings in the courtroom but

has to participate from the holding cell where the use of the available facilities will avoid frequent interruptions of proceedings and where his ability to follow proceedings will be enhanced. Therefore, in order to avoid substantial delays and because the interest of justice so requires, the Chamber in accordance with the medical report ordered IENG Sary to participate in the day's proceedings from the holding cell.

It also appeared that Nuon Chea's condition similarly prevents him from attending proceedings in the courtroom and that he has to participate from the holding cell.

- Oral Order instructing KHIEU Samphan be brought to the holding cell and returned to the court room for the afternoon proceedings.
- Order to bring SA Vi (TCW-620) back to his accommodations and to return him to the courtroom for the hearing on 12 December 2012.
- Order to bring the Accused NUON Chea, IENG Sary and KHIEU Samphan back to the detention facility and have them returned to the courtroom by 9:00am on 09 January 2013.

#### Orders for Adjournment of Hearing

The hearing will resume on 09 January 2013 at 9:00 am.
