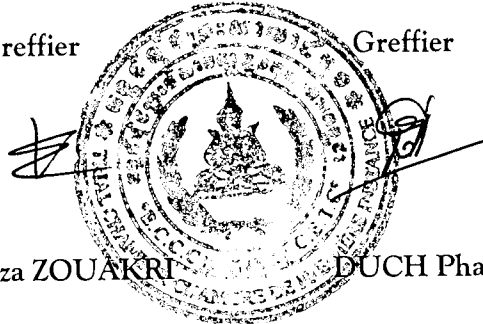
**Orders for Adjournment of Hearing**
