Subject: Points of View, Stance and Ways of Defeating the *Yuon* Invaders.

I- General information about the enemy and us

The strong frontline and weak base of the *Yuon* invaders, and the situation of hard frontline and strong base in all fields of politics, economics, and military, both locally and overseas, have been elaborated on in all aspects in the Democratic Kampuchea Government's communiqué by the Comrade President of the State Presidium on December 31, 1977. All comrades will understand more clearly from this document. Here, we do not need to talk more about these issues.

II- Grasp hold of the *Yuon*'s invading strategies regularly in order to master views and stance beforehand:

The purposes of the *Yuon* in invading our territory include rice and economic robbery, destruction of villages and our peoples' lives, and obstruction of our sparkling Revolutionary Movement. In the mean time, strategically, they attempt to defeat our Revolution; and if they are successful, they will attack the independence, territorial integrity and sovereignty of Kampuchea, and the mastery of independent and self-reliant politics of Cambodia, which are successful on both local and international scenes.

So, if they can defeat Kampuchea, together with the Soviet, Cuba and their allies, they will be increasingly insolent and bullying towards other countries in Southeast Asia and other regions.

Based on the above-mentioned points of view, with the Soviet's support and direct involvement, the aggressors will be persistent in invading us. These are the viewpoints that we have to foresee the persistent and long-term situations of our struggle clearly so that we will have mastery in viewpoints, stance and all kind of actions in order to challenge and break the aggressive strategies of the Soviets and the

combatants, and each target commanding committee, so as to exchange experience and improve the performance regularly.

The good implementation of these military, people's war, and rebellious war lines of the Party is "The invaders will dump piles of their bones on our territory".
