
## I. UPDATED LISTS OF DOCUMENTS AND EXHIBITS

1. Pursuant to this Chamber's 'Order to File Updated Material in Preparation for Trial in Case 002/02' (the 'Case 002/02 Trial Preparation Order'),<sup>1</sup> the Parties were ordered to file updated lists of documents and exhibits they intend to offer in the Case 002/02 trial.<sup>2</sup> The Co-Lawyers for Nuon Chea (the 'Defence') hereby notify the Chamber that since the Defence did not submit original lists of documents and exhibits pursuant to the Chamber's 'Order to File Material in Preparation for Trial' in 2011,<sup>3</sup> it is unable to update any such lists and is therefore unable to comply with the Chamber's order to submit updated lists of documents and exhibits.

## II. LISTS OF NEW DOCUMENTS AND EXHIBITS

2. The Chamber stipulated in its Case 002/02 Trial Preparation Order that '[a]ny application to add new or additional documents and exhibits which are not already before the Chamber pursuant to Case 002/01, shall be filed in accordance with Internal Rule 87(4)'.<sup>4</sup> In the 'Parties' Joint Request for Clarification Regarding the Application of Rule 87(4) in Case 002/2', all Parties have submitted that Internal Rule 87(4) should apply as of the Initial Hearing in Case 002/02.<sup>5</sup> The Defence hereby provides notice of its intention to submit lists of new documents and exhibits prior to the Initial Hearing.
