the NUON Chea to disqualify Trial Chamber judges

On 11 August 2014, the Trial Chamber received an email from the NUON Chea Defence notifying the Trial Chamber of its intention to seek the disqualification from any further trials in Case 002 of the following judges: President NIL Nonn, YA Sokhan, Jean-Marc LAVERGNE and YOU Ottara. The NUON Chea Defence does not seek to disqualify Judge Silvia CARTWRIGHT, on the basis that she shall leave the ECCC before 1 September 2014. The NUON Chea Defence anticipates making its application shortly before or on Monday 8 September 2014 and asserts that this complies with Internal Rule 34(3). The NUON Chea Defence requests an extension of the relevant page limit to a maximum of 30 pages in English and seeks permission to file its application in one language (English) only, with a Khmer translation to follow as soon as possible.

According to Internal Rule 34(6), in the event of an application seeking to disqualify multiple judges such that it is impossible to convene a Chamber to hear the application, the Judicial Administration Committee ("JAC") shall choose additional judges from amongst the ECCC's judges.

While no disqualification application has yet been made, the Trial Chamber considers that certain matters raised by the NUON Chea Defence in its email may require consideration by the panel in advance of the filing of such application.

The Trial Chamber therefore requests that the JAC constitute a panel of judges from amongst the ECCC judges in order to deal with the matters raised by the NUON Chea Defence's email and the application when it is made. The Trial Chamber is unaware whether any other party intends to apply to disqualify the same judges as sought by the NUON Chea Defence or additional judges. The NUON Chea Defence's email is attached.
