As per the above-mentioned subject and references, I have the honor to inform Your Excellency President that pursuant to Article 8 of the Law on the Statute of the Bar Association of the Kingdom of Cambodia (BAKC), BAKC is an organization bringing together all lawyers who practice their legal profession within the Kingdom of Cambodia. This means that the lawyers who are registered with the BAKC shall be under the jurisdiction of the BAKC. BAKC has a duty to protect and uphold the professionalism of the lawyers, ensuring that this profession is practiced with quality and dignity in line with the rules for professional lawyers, including the Law of Statute of Lawyers, Lawyer's Code of Ethics, and Internal Regulations of the BAKC. Every lawyer shall be responsible before the BAKC Council in the event of breach of any rule above. When a lawyer commits any misconduct in practicing their profession, the lawyer in question shall be subjected to sanction imposed by the Council of the BAKC, the body with competence to impose sanction against lawyers.
