Pursuant to Rule 39(4), the Co-Lawyers for Nuon Chea (the “Defence”) hereby submit this urgent request for an extension of time to respond to the Co-Prosecutors’ appeal of the Case 002/01 Judgement:

1. On 28 November 2014, the Co-Prosecutors filed their appeal against the Case 002/01 Judgement (“Co-Prosecutors’ Appeal”).<sup>1</sup>
2. On 1 December 2014, the Co-Lawyers for Khieu Samphân requested that the Supreme Court Chamber grant them an extension of time to file their response to the Co-Prosecutors’ Appeal.<sup>2</sup>
3. The Defence intends to respond to the Co-Prosecutors’ Appeal and to seek leave for a similar extension of time for its response. The Defence adopts the reasoning of the Co-Lawyers for Khieu Samphân for the extension request.<sup>3</sup>
4. For these reasons, the Defence hereby requests that the Supreme Court Chamber:
  - a. fix a deadline of 30 days from 29 December 2014 for the filing of its response to the Co-Prosecutors’ Appeal; and
  - b. issue an urgent decision in respect of this request, given the impending current deadline for the Defence’s response to the Co-Prosecutors’ Appeal.
