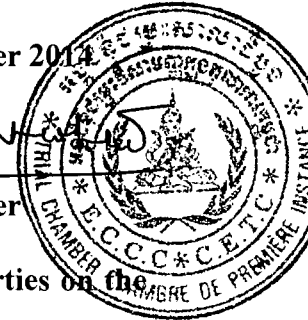

**SUBJECT: Decision on the Placement of Documents Proposed by the Parties on the Case File**

1. The Trial Chamber is seized of a request by the Office of the Co-Prosecutors to place 499 documents on the Case File and assign them reference numbers (E307/8). Pursuant to the Trial Chamber's Order E305, the Co-Prosecutors filed lists of proposed documents pursuant Rule 80(3) (E305/13 and E305/13/1, respectively). Annex C2 to document E305/13 contains 473 documents. Annex D3 to document E305/13/1 contains 26 additional documents also not on Case File 002. These documents are currently accessible by the parties through the OCP partition in Zylab. The Co-Prosecutors requests that the Trial Chamber (1) transfer all documents listed on Annexes C2 and D3 to the Case File, (2) assign these documents Case File numbers, and (3) make these documents available on Zylab.

2. The Trial Chamber also notes that the KHIEU Samphan Defence, the NUON Chea Defence, and the Civil Party Co-Lead Lawyers have also filed lists of proposed documents pursuant to Order E305 (E305/12, E307/5, and E305/14, respectively). These proposed documents are not currently on the Case File.

3. Considering that none of the parties have objected to the placement of these documents on the Case File and that such placement is in the interests of justice since it will facilitate access to the documents and later discussion on admissibility, the Trial Chamber will place these documents on the Case File. The documents will be available to all parties on Zylab through the document reference numbers listed in the annexes to this memorandum.

4. This memorandum is the official response to E307/8. The Trial Chamber will soon issue a scheduling order for the objections to and discussion of the admissibility of the documents proposed by the parties in their lists of proposed documents.
