## SCHEDULING ORDER FOR EVIDENTIARY PROCEEDINGS

SON Arun Victor KOPPE KONG Sam Onn Arthur VERCKEN Anta GUISSÉ **THE TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia ("ECCC");

**BEING SEISED** of Case File No. 002/19-09-2007-ECCC/TC pursuant to the Decisions on Appeal Against the Closing Order by IENG Sary, IENG Thirith, NUON Chea and KHIEU Samphan, rendered by the Pre-Trial Chamber on 13 January 2011;<sup>1</sup>

**NOTING** the Trial Chamber's Case 002/02 Scheduling Orders of 19 September 2014 and 3 November 2014;<sup>2</sup>

**RECALLING** that obstruction of the proceedings by counsel for KHIEU Samphan<sup>3</sup> forced the Chamber to adjourn proceedings until 8 January 2015;<sup>4</sup>

**NOTING** the statement made by international Co-Counsel for KHIEU Samphan that the Defence would be ready to participate in Case 002/02 after the filing of KHIEU Samphan's appeal brief against the Judgement in Case 002/01;<sup>5</sup>

NOTING KHIEU Samphan's appeal brief is due on 29 December 2014;<sup>6</sup>

**NOTING** the Co-Prosecutors and Civil Party Lead Co-Lawyers' joint request to fix the number of sitting days at four per week as of 8 January 2015;<sup>7</sup>

**RECALLING** the Chamber's earlier finding that the parties would benefit from a reduced hearing schedule of three days per week while preparing appeal briefs, at least through December 2014;<sup>8</sup>

**RECALLING** the Chamber's subsequent ruling further decreasing the number of sitting days to two days per week until the filing of the appeal brief in December 2014 in an attempt to

balance the needs outlined by the KHIEU Samphan Defence with the right of the other parties to an expeditious trial;<sup>9</sup>

**CONSIDERING** that a reduced hearing schedule of two days per week will no longer be justified following the anticipated filing of KHIEU Samphan's appeal brief by 29 December 2014;

**CONSIDERING** that, in view of the age of each Accused, new fitness assessments would permit the Chamber to reassess the sitting schedule in light of up-to-date information;<sup>10</sup>

**FINDING** therefore appropriate to maintain a reduced schedule of three sitting days per week until the Chamber is able to consider such new fitness assessments;

**RECALLING** the Trial Chamber's Decision on Sequencing of Trial Proceedings in Case 002/02 and its decision to prioritise a hearing of evidence on the Tram Kok Cooperatives and Kraing Ta Chan Security Centre;<sup>11</sup>

**SCHEDULES** the commencement and duration of the initial segment of the evidentiary proceedings in Case 002/02, from Thursday 8 January 2015;

**ANNOUNCES** that unless otherwise specified, the Chamber will sit three days each week, until a new fitness assessment of both Accused is completed, beginning each day at 9:00 am and ending at 4:00 pm with a lunch break from 12:00 pm to 1:30 pm and a morning and afternoon break as determined by the President;

**NOTES** that the parties have been informed by email of the updated order for the appearance of witnesses, experts and Civil Parties for the first trial topic (Annex I); and

**ATTACHES** a schedule for the evidentiary hearings in Case 002/02 for the beginning of 2015 (Annex II).
