Summary of Proceedings

Opening of the Substantive Hearing

The President opened the proceedings and the Greffier informed the Chamber that all parties were present except the Defence Team for KHIEU Samphan.

Presence of KHIEU Samphan Defence counsel

The President requested that KHIEU Samphan inform the Chamber of the whereabouts of his Defence counsel. KHIEU Samphan confirmed that he instructed his counsel not to attend the proceedings and informed the Chamber that his international counsel are in Paris.

Co-Prosecutors' Amicus Curiae Counsel Proposal

The International Co-Prosecutor clarified the Co-Prosecutors' proposal for the appointment of *amicus curiae*. The Lead Co-Lawyer for the Civil Parties joined the Co-Prosecutors in their request.

Advisement to KHIEU Samphan

The Chamber advised KHIEU Samphan that should he instruct counsel not to attend the substantive hearings or otherwise participate in proceedings in Case 002/02, the Chamber may decide to appoint counsel not of his choosing or take other appropriate actions in order to ensure the interest of justice to fair and expeditious proceedings. KHIEU Samphan responded.

Adjournment of Hearing

Hearing adjourned until 24 November 2014.

Oral Orders/Decisions:

- The Trial Chamber ordered KHIEU Samphan to inform the Chamber through the Defence Support Section by 18 November 2014 at 4.30pm whether he has withdrawn his instruction to counsel not to participate in proceedings in Case 002/02 (13.54).
- The Trial Chamber instructed all parties to attend the hearing on 24 November 2014 (13.56).
- The Trial Chamber instructed WESU to coordinate the travel of witnesses to their residence until further notice (13.56).
- The President ordered security to bring the Accused to the detention facilities and return them to the courtroom on 24 November 2014 (13.56).

The hearing is adjourned to 24 November 2014 at 9:00 a.m.
