#### Opening of the Substantive Hearing

The President opened the proceedings and the Greffier informed the Chamber that all parties were present except for the KHIEU Samphan Defence Co-Lawyer and accused NOUN Chea. NUON Chea was present in his holding cell.

#### NUON Chea request to follow the hearing from the holding cell

NUON Chea Defence requested to follow the proceedings from the holding cell and waived his right to follow the proceedings from the courtroom. The Trial Chamber granted the request.

#### Recognition of new Civil Party lawyer

Upon request of the Civil Party Co-Lawyer, the Trial Chamber recognized Mr. Mahesh Rai as International Lawyer for Civil Parties for the purpose of proceedings before the Court.

#### KHIEU Samphan Defence objection

KHIEU Samphan Defence requested the Chamber to instruct to the Co-Prosecutor not to list the names of the Standby Counsel for the Accused Khieu Samphan in its filings in the section of the cover page listing the KHIEU Samphan Defence.

#### Continuation of testimony of Civil Party 2-TCCP-271

The Co-Prosecutor resumes the questioning of 2-TCCP-271, followed by the Trial Chamber, NOUN Chea Defence, and KHIEU Samphan Defence.

#### Request to hold in camera hearings

Due to 2-TCCP-271's safety concerns, Civil Party Co-Lawyer requested that the Chamber conduct the current proceedings in-camera. NUON Chea Defence and KHIEU Samphan Defence objected based on the untimeliness of the request and the lack of substantive reasons for the request.

After the midday adjournment, the Chamber heard the 2-TCCP-271's submissions, ordering the AV-Unit to discontinue the public audio feed for that purpose. The Chamber then recessed to deliberate.

The Chamber, through Judge Fenz, then stated that it did not have sufficient information in order to decide the issue and postponed its ruling. The Chamber will request a report from the Witness Protection Unit. In order to preserve the objective of the request, the Chamber disallowed questions regarding the identity of cadres and informed 2-TCCP-271 that for the time being he could refuse to answer questions that would Krang Ta Chan staff members.

#### Oral ruling on closed session hearings

The Trial Chamber granted the Civil Party Co-Lawyer requests to continue with the hearings in closed session in order to give the opportunity to Civil Party Co-Lawyer to explain the grounds on which the request is based. The Trial Chamber instructed the AV Unit to disconnect the audio of the proceedings.
