Dear Parties,

The Trial Chamber has asked me to convey the following in relation to the Civil Party Lead Co-Lawyers' proposed schedule for the hearings on Civil Party suffering (E315/1/1) and the NUON Chea Defence oral submissions regarding the procedures for such hearings.

The Chamber recalls the procedure adopted by the Trial Chamber for hearings on Civil Party suffering (E315/1) when it ruled: "In the event that Civil Party statements on suffering introduce new facts of allegations against the Accused which have not been subject to adversarial debate, the Chamber may consider it to be in the interests of justice to allow the parties an opportunity to question the relevant Civil Party in relation to those allegations." The Lead Co-Lawyer's proposal allows for 25 minutes to be allocated to the parties for questioning each Civil Party (E315/1/1.1). At this time, when the Chamber does not know how much time, if any, a Civil Party will spend on talking about facts as opposed to suffering, the Chamber considers it premature to allocate additional time, as requested by the NUON Chea Defence, for the parties to question every Civil Party. Nonetheless, the Chamber will consider parties' reasoned applications for additional time to question particular Civil Parties on a case by case basis. The Chamber therefore accepts the Lead Co-Lawyers proposed time allocations for hearing Civil Parties.

However, in order to allow the Chamber flexibility to permit, when appropriate, additional questions to be posed to Civil Parties, the hearings on Civil Party suffering will now start tomorrow afternoon, Wednesday 1 April at 1:00pm and continue through Friday afternoon, as needed. The Lead Co-Lawyers are directed to inform the Chamber and parties of the first two Civil Parties to be heard on Wednesday afternoon and to file an amended schedule.
