Report

I beg to report to the Angkar for its information as follows:

Angkar has decided that these 5 persons be brought to your elder brother's place.

These persons had their activities as follows:

- 1). THACH Âng (ថាច់ អង់), Khmer Kampuchea Krom, was a military with a rank as Corporal. He has fled from Prey Ta Kau Village, Trapeang Thom North Commune to Ta Ny. His activities were he was going out only during the night, he stole cassavas for food. He walked up to Nhaeng Nhang Commune at night at 03.00a.m, when the militia called him, he ran to the bushes and hid himself there for one night, then he was found. His purpose was that if he failed to flee to Ta Ny, he would wish go to District 44.
- 2). SAU Phon (សៅផុន), was a former Chief Sergeant of the military. His activities were that he boasted that he had the money of 10,000 and a forged official travel document. (He was sent here from Kbal Pau Commune (ក្បាលប៉ៅ កោះផ្លី)។
- 3). SIN Thim (ស៊ីន ធីម), the Angkar of Trapeang Thom (South) has sent him to Angkar for making a decision...??? the place (was not reported).
- 4). Neary Nup Hieng (នារី នុប ហៀង), this female youth was also sent by the Angkar of Khporp Trabaek Commune - it is not known for what reason was (did not receive any report).

Therefore, I beg your Comrade elder brother to please interrogate, examine and follow them up.

Report

I beg to respectfully report to the Angkar for its information as follows:

On 4/1/77, we have received a person who was sent from the Kbal Pau Commune (ឃុំក្បាលពៅធំ).

The name of this person is SAU Phan (សៀម ផាន), whose age is 36 years old, father's name: SAU Ean (សៀម អ៊ាន), mother's name: CHAN Day (ចាន់ ដាយ), his native village was in Koh Village, Koh Keo Commune, Lovea Em District, Kandal Province. Before 1970, his occupation was a driver, until June 1974, he joined in the Army with a rank as a Chief Sergeant, and went for a military operation in Kompong Som. He said that in 1974 he ceased to be in the military, and instead turned to a fishing business.

Until 17th April this person moved out from Kompong Som, and currently he is living in Trapeang Pau Village, Samrong Commune, Tram Kak District in Takeo Province.

This person was assigned to work in Kbal Pau, and had committed a fault. This fault was not totally confessed by him. What he confessed was about he possessed an amount of money of over 100,000 riels. Concerning the fact that he had a forged travel document, he did not confess. According to a report from the Kbal Pau Commune informed us that this person had a wife, but she had fled to Vietnam already. But this time, he told that he wife is in Kien Svay Ditricth now. But apart from the above fault, it is not known what else are his faults.
