#### Summary of Proceedings

#### Opening of hearing and report on attendance of Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present, except the international co-counsel for KHIEU Samphan. The Accused NUON Chea was present in his holding cell.

### NUON Chea request to follow the proceedings from the holding cell

The Trial Chamber granted the request of the NUON Chea Defence Team for NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

#### Notification of parties regarding the Trial Management Meeting

The Trial Chamber notified the parties that the testimony of witness 2-TCW-803 will be postponed due additional time needed by the parties to review documents related to 2-TCW-803's testimony and due to this Trial Management Meeting.

#### Questioning of Witness VAN Soeun (2-TCW-847)

The NUON Chea Defence and the KHIEU Samphan Defence questioned witness VAN Soeun (2-TCW-847).

#### NUON Chea request to for a site visit to the Krang Ta Chan Security Office

The Defence requested a site visit by all parties in order to observe the physical dimensions and other details of Krang Ta Chan. The Trial Chamber suspended ruling on the request to visit the detention facility, stating that it would later rule on the request in due course.

#### NUON Chea request for closed session

The NUON Chea Defence requested questioning 2-TCW-847 in camera to avoid violating the Chamber's rules protecting the identity of alleged sexual assault victims. The Chamber granted the request. The Chamber ordered that all persons present in the public gallery be escorted. The Chamber also instructed the A/V Unit to discontinue the audio and visual broadcast of the proceedings.

### Defence request to hold Trial Management Meeting in public session

NUON Chea Defence requested that the Trial Management meeting be held in public. The KHIEU Samphan Defence joined the NUON Chea Defence's request. The Chamber granted the request, based on the public interest, on the condition that the parties would respect the confidentiality of Case 003 and 004 materials in accordance with E319/7.

#### Trial Management Meeting

#### Defence motion on disclosure of case 003 and 004 statements

NUON Chea Defence argued that it does not have sufficient time to properly read and analyse the Case 003 and 004 documents disclosed by the OCP and that several of these

documents are not relevant. The NUON Chea defence requested the temporary adjournment of hearings in order to review statements from Cases 003 and 004 disclosed by OCP.

The KHIEU Samphan Defence also noted its lack of time and resources to prepare a defence and the need for more time and disclosure to analyse documents from cases 003 and 004.

The Trial Chamber asked about the amount of additional time needed for document analysis by the Defence. The NUON Chea Defence stated that a definite answer would be impossible to give at that moment. The KHIEU Samphan Defence requested six weeks. The OCP alleged inconsistencies between the Defence's request of additional time to analyse document and the request for more documentary disclosure from other cases.

The Co-Prosecution stated that it would not file a written response to the Defence's motion. The Co-Prosecution noted that the alteration of segments would collide with matters of disclosure of documents of cases 003 and 004 – and it is the OCIJ who is responsible for such disclosure.

#### Additionally:

- The NUON Chea Defence requested assurances from the Chamber that the Khmer Krom will not be included as a 'targeted group' in case 002/02. The Co-Prosecution opposed excluding evidence of attacks on Khmer Krom, since attacking enemies was part of Khmer Rouge policy.
- The NUON Chea Defence requested an order to the OCP requesting the disclosure of additional relevant evidence from cases 003 and 004. The KHIEU Samphan Defence mentioned the possible need to recall certain witnesses if these additional documents from cases 003 and 004 are not disclosed. The KHIEU Samphan Defence also noted the lack of translation to French of certain documents. The Lead Co-Lawyer for Civil Parties stated that it is of interest that as many documents possible be disclosed. Also, it was mentioned that the OCIJ should broaden the conditions for disclosure. The NUON Chea Defence later proposed to invite the OCIJ to disclose the matters that would be relevant to case 002/02.
