Summary of Proceedings

Opening of hearing and report on attendance of Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present. The Accused NUON Chea was present in the holding cell.

NUON Chea request to follow the hearing from the holding cell

The Trial Chamber granted the request of the NUON Chea Defence for NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Hearing on Harm suffered by Civil Party EAM Yen (2-TCCP-985)

NUON Chea Defence and KHIEU Samphan Defence posed questions to the Civil Party EAM Yen (2-TCCP-985) regarding the harm suffered during the Democratic Kampuchea.

Hearing on Harm suffered by Civil Party THANN Thim (2-TCCP-288)

The Trial Chamber, Lead Co-Lawyers and Co-Prosecutors posed questions to the Civil Party THANN Thim (2-TCCP-288) regarding the harm suffered during the Democratic Kampuchea.

During the hearing, the NUON Chea Defence requested that the Civil Party be summoned to a later date to be heard about his knowledge of facts relevant to Case 002/02. The KHIEU Samphan Defence made no observations.

The Co-Prosecutors submitted that it was possible to continue asking additional questions during the current hearing, and that it was unnecessary to recall the Civil Party. The Lead Co-Lawyers did not support the application of the NUON Chea Defence.

The Trial Chamber granted the request by the NUON Chea Defence and decided to adjourn the hearing of the Civil Party THANN Thim (2-TCCP-288). The Civil Party will be summoned to return to the court in due course.

Lead Co-Lawyers explanation of reason Chau Ny's name is mentioned in several Civil Party applications

In response to a request for clarification from the Trial Chamber, the Lead Co-Lawyers explained that CHAU Ny's name appears on several Civil Party application forms because he was in charge of outreach and complaints in 2007 and 2008 in Takeo province, although the Lead Co-Lawyers could not confirm this with certainty.

Hearing on Harm suffered by Civil Party BENG Boeun (2-TCCP-981)

The Trial Chamber, Lead Co-Lawyers, Co-Prosecutors, NUON Chea Defence and KHIEU Samphan Defence posed questions to the Civil Party BENG Boeun (2-TCCP-981) regarding the harm suffered during the Democratic Kampuchea.

Hearing on Harm suffered by Civil Party YEM Khonny (2-TCCP-983)

The Trial Chamber and Lead Co-Lawyers posed questions to the Civil Party YEM Khonny (2-TCCP-983) regarding the harm suffered during the Democratic Kampuchea.
