Summary of Proceedings

Opening of hearing and report on attendance of Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present. The Accused NUON Chea was present in the holding cell.

NUON Chea request to follow the hearing from the holding cell

The Trial Chamber granted the request of the NUON Chea Defence Team for NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Hearing of Civil Party THANN Thim (2-TCCP-288)

The Trial Chamber, Lead Co-Lawyers, Co-Prosecutors, NUON Chea Defence and KHIEU Samphan Defence questioned the Civil Party THANN Thim (2-TCCP-288). THANN Thim (2-TCCP-288) made a statement on the suffering he endured during the Democratic Kampuchea regime.

<u>Decision on NUON Chea Defence request for clarification on targeting of Khmer Krom forthcoming</u>

Following the NUON Chea Defence's objection to questions relating to the treatment of Khmer Krom, the Chamber announced that it will render a decision on whether Case 002/02 contains charges concerning the Khmer Krom as a specifically targeted group in due course.

NUON Chea Defence request for guidance on questions pertaining to Ang Roka

The NUON Chea Defence requested guidance on the relevance of questions pertaining to Ang Roka. The Trial Chamber decided that Parties could ask questions on facts relating to Ang Roka, however such questions should not be detailed.

Hearing of Witness PECH Chim alias Ta Chim (2-TCW-809)

The Trial Chamber and the Co-Prosecutors questioned the Witness PECH Chim (2-TCW-809).

<u>Co-Prosecutors' submission on the NUON Chea Defence request for the Chamber to hear additional witnesses</u>

In response to the NUON Chea Defence request for the Chamber to hear additional witnesses on the Tram Kak Cooperatives and Kraing Ta Chan Security Centre, the Co-Prosecutors stated that they agree that the Chamber should call two of the proposed witnesses, but within the purges and forced marriages sections of the trial. The Co-Prosecutors took no position on the other proposed witnesses. The KHIEU Samphan Defence supported the NUON Chea Defence request. The Trial Chamber announced that it will rule on the issue in due course.
