I, JUDGE KONG SRIM, President of the Supreme Court Chamber of the Extraordinary Chambers in the Courts of Cambodia for the Prosecution of Crimes Committed during the Period of Democratic Kampuchea between 17 April 1975 and 6 January 1979, which is seized of appeals lodged by the Co-Prosecutors, NUON Chea, and KHIEU Samphân¹ against the judgment of the Trial Chamber in Case 002/01 of 7 August 2014;²

NOTING Internal Rule 108(5),³ according to which the President of the Supreme Court Chamber shall appoint national and international judges to be co-rapporteurs for appeals;

CONSIDERING that, in view of the large number of issues raised in the appeals as well as the overlap between several of those issues, it is in the interest of the effective management of the appeals to appoint co-rapporteurs for several sets of issues;⁴

- 2) **Judge YA Narin** and **Judge Florence Ndepele MWACHANDE-MUMBA** as co-rapporteurs for all issues arising from the appeals that are related to Trial Chamber's approach to the evidence and the Trial Chamber's findings relevant to the crimes for which NUON Chea and KHIEU Samphân were convicted; and
- 3) **Judge SOM Sereyvuth** and **Judge Agnieszka KLONOWIECKA-MILART** as co-rapporteurs for all issues arising from the appeals that are related to the Trial Chamber's findings relevant to NUON Chea's and KHIEU Samphân's individual criminal responsibility.
