Report

We would like to respect Angkar and beg to report for its knowledge as follows:

On 2/10/77, we have received a youth who was sent over from Popeil Commune.

- That youth named Nget Kun, (new people), aged 25, his father's name: Nget Kauy, mother's name: Son. His native village was Trav Em Village, Popeil Commune, Tram Kak District, Takeo.
- This person fled to Phnom Penh in 1964, his occupation was actor of the Bassac theatre, at the Bakk Sreng Theatre House.
- It was until 17 April, when he moved to live in Trav Em village, Popeil Commune.
- Later on, this youth fled from Popeil Commune of Tram Kak District, to Sreuv Village, Dâng Tuong Commune, Toul Meas District (Kampot), in order to have medical treatment for syphilis.
- On 1/10/77, this youth fled from Dâng Tuong Commune of Touk Meas District, back to live in Popeil Commune of Tram Kâk District, with his father, and his brothers and sisters, but he had no letter (of travel authorization) at all for this travel.
- This youth has been fleeing back and forth, he had fled to live in Touk Meas District in Kampot Province for one year. Until this year he is returning.

This is to report to the Party's Organization of the District 105, for its information as follows:

There is a new person named Pich Savann, who (formerly) was an engineer, who has been assigned by the Cooperative to herd the ducks in the rice fields. This person named Pich Savann, has chased the ducks into to a rice field to eat rice in there. He was called for an (oral) re-education for the first time already.
