**Noting** Rules 21, 41, 45, 55, 57 and 72 of the Internal Rules of the Extraordinary Chambers in the Courts of Cambodia;

**Noting** the *Co-Prosecutors’ Second Introductory Submission Regarding the Revolutionary Army of Kampuchea* filed on 7 September 2009;<sup>1</sup>

**Noting** the *Co-Prosecutors’ Supplementary Submission Regarding Crime Sites Related to Case 003* filed on 31 October 2014 (“Supplementary Submission”);<sup>2</sup>

**Noting** the judicial investigation relating to alleged violations of the **1956 Penal Code, Crimes against Humanity and Grave Breaches of the Geneva Conventions of 12 August 1949**, offences defined and punishable under Articles 3(new), 5, 6, 29 and 39 of the ECCC Law and Articles 500, 501, 503, 505, 506, 507 and 508 of the 1956 Penal Code;

**Noting** the Disagreements registered on 7 February 2013 and 22 February 2013;

**Noting** the Disagreement registered on 17 July 2014;

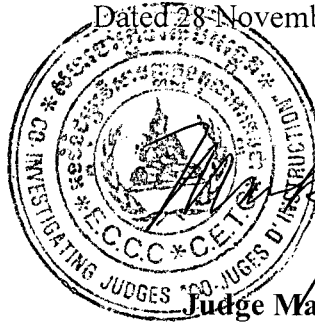
