KARNAVAS ("the Co-Lawyers") hereby notify the Office of the Co-Investigating Judges and the Office of the Co-Prosecutors ("OCP") of the Trial Chamber's Termination of the Proceedings Against the Accused IENG Sary ("Termination Notice").
