Pursuant to the Trial Chamber's decision,¹ the Co-Lawyers for Mr. Nuon Chea (the "Defence") submits this indication of the portions of document E307/5.2.8 it wishes to put before the Trial Chamber for admission in Case 002/02:

I. PROCEDURAL HISTORY

- 1. On 8 April 2014 the Trial Chamber directed all parties to provide updated lists of documents previously filed and updated lists of intended exhibits for Case 002/02. The Defence filed its updated documents list on 24 July 2014.² This list included document E307/5.2.8; a compilation of 21 biographies (the "Kurzbiographies") produced by the German Democratic Republic Ministry of State Security.³
- 2. On 11 December 2014, the Trial Chamber granted all parties the opportunity to submit written objections to documents on the other parties' respective updated documents lists. On 30 June 2015, the Trial Chamber issued its decision on the admissibility of documents contained in the parties' updated documents lists, the parties' objections thereto, and on the parties' other submissions.
- 3. In its Decision, the Trial Chamber requested that the Defence file, within 14 days of the Decision, an indication of the portions of E307/5.2.8 it wishes to put before the Trial Chamber.⁶

II. INDICATION OF PORTIONS OF E307/5.2.8 THE NUON CHEA DEFENCE WISHES TO PUT BEFORE THE CHAMBER

- 4. Document E307/5.2.8 is currently only available in German. To assist the Trial Chamber in assessing whether this document is relevant to Case 002/02, the Trial Chamber has requested that the Defence file an indication of which portions of this document it seeks to put before the Trial Chamber.⁷
- 5. The Defence now submits its indications. These are set out at Annex A to this filing (the 'Indication'). Pursuant to the Trial Chamber's instructions, the Indication includes, where possible, an expanded description of each portion's nature and contents as well as
