Opening of the hearing and report on attendance of the parties

The President opened the proceedings and introduced SCW-4. The Greffier informed the Chamber that all Parties were present. NUON Chea was present in the courtroom until 10:39 then followed the hearing from the holding cell.

Co-Rapporteurs' Report

Judge YA and Judge MWACHANDE-MUMBA read out the Co-Rapporteurs' Report relating to the command structure of the Communist Party of Kampuchea, the alleged policy to target Khmer Republic soldiers and officials and the events at Tuol Po Chrey.

Informing the Witness of his rights

The President informed SCW-4 of his rights.

Questioning of SCW-4

The Co-Lawyers for NUON Chea, the Co-Lawyers for KHIEU Samphân, the Civil Party Lead Co-Lawyers, the Co-Prosecutors and the Supreme Court Chamber questioned SCW-4.
